Vervanging van artikel 14 van Wet 32 van 1961.

1. Artikel 14 van die Grondwet van die Republiek van Suid-Afrika, 1961, word hierby deur die volgende artikel vervang:

„Salaris van Staatspresident.

14. (1) Daar word aan die Staatspresident, benewens die toelaes wat die Parlement van tyd tot tyd bewillig, en afgesien van die voorregte wat hy mag geniet, uit die Gekonsolideerde Inkomstefonds en ten laste daarvan 'n salaris betaal wat, behoudens die bepalings van subartikel (3), van tyd tot tyd by besluit van die Senaat en die Volksraad bepaal word.

(2) Die salaris onmiddellik voor die inwerking-treding van hierdie Wet aan die Staatspresident betaalbaar, word geag kragtens subartikel (1) bepaal te gewees het.

(3) Die salaris van die Staatspresident word nie gedurende sy ampstermyn verminder nie.”.

Wysiging van artikel 15 van Wet 32 van 1961, soos gewysig deur artikel 18 van Wet 102 van 1965, artikel 2 van Wet 79 van 1968 en artikel 1 van Wet 93 van 1971.

2. Artikel 15 van die Grondwet van die Republiek van Suid-Afrika, 1961, word hierby gewysig deur paragraaf (a) van subartikel (1) deur die volgende paragraaf te vervang:

„(a) aan iemand wat te eniger tyd na die eerste dag van April 1968 die amp van Staatspresident beklee het, 'n jaarlikse pensioen betaal teen 'n skaal gelykstaande met vyf-en-sewentig persent van die jaarlikse salaris wat op die dag waarop hy sy amp ontruim het, aan hom betaalbaar was;”.

ACT

To amend the Republic of South Africa Constitution Act, 1961.

*(Afrikaans text signed by the State President.)
(Assented to 1 October 1974.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. The following section is hereby substituted for section 14 of the Republic of South Africa Constitution Act, 1961: Substitution of section 14 of Act 32 of 1961.

“Salary of State President. **14.** (1) There shall be paid to the State President out of and as a charge on the Consolidated Revenue Fund, in addition to any allowances appropriated from time to time by Parliament, and apart from any privileges which he may enjoy, a salary determined, subject to the provisions of subsection (3), by resolution of the Senate and the House of Assembly from time to time.

(2) The salary payable to the State President immediately prior to the commencement of this Act, shall be deemed to have been determined under subsection (1).

(3) The salary of the State President shall not be reduced during his term of office.”.

2. Section 15 of the Republic of South Africa Constitution Act, 1961, is hereby amended by the substitution of the following paragraph for paragraph (a) of subsection (1): Amendment of section 15 of Act 32 of 1961, as amended by section 18 of Act 102 of 1965, section 2 of Act 79 of 1968 and section 1 of Act 93 of 1971.

“(a) to any person who has at any time after the first day of April, 1968, occupied the office of State President, a yearly pension at a rate equal to seventy-five per cent of the yearly salary to which he was entitled on the day upon which he vacated office;”.

3. This Act shall be called the Constitution Amendment Act, 1974. Short title.
