PARLIAMENTARY AND PROVINCIAL MEDICAL  
AID SCHEME ACT, 1975

## ACT

**To provide for compulsory membership of the Parmed Medical Aid Scheme of members of certain legislative bodies and of certain other persons; to provide for the deduction of contributions payable to the said medical aid scheme from the salaries payable to certain persons; to repeal the Parliamentary Medical Aid Scheme Act, 1974; and to provide for incidental matters.**

(Assented to 14 April 1975.)

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Compulsory  
membership of  
Parmed Medical

**1. Every person who is or becomes—**

- (a) while not being a member of either the Senate or the House of Assembly, a Minister or Deputy Minister;
- (b) an Administrator of a province or the Administrator of the territory of South West Africa;
- (c) a member of the Senate, of the House of Assembly, of the provincial council of a province or of the Legislative Assembly of the territory of South West Africa;
- (d) while not being a member of a provincial council, a member of the executive committee of a province or, while not being a member of the Legislative Assembly of the territory of South West Africa, a member of the Executive Committee of the said territory,

shall, for as long as he holds that office or post, be a member of the Parmed Medical Aid Scheme, subject to the rules of that medical aid scheme as registered in accordance with the provisions of the Medical Schemes Act, 1967 (Act No. 72 of 1967).

**2. (1) There shall be deducted monthly from the salary payable to any person—**

- (a) holding any office or post mentioned in section 1; or
- (b) who, after ceasing to hold any such office or post, has continuously remained a member of the Parmed Medical Aid Scheme, and at any time after so ceasing to hold such office or post, holds any other office or post in respect of which a salary is paid to him by the State (including any provincial administration or the administration of the territory of South West Africa),

an amount equal to the amount which is payable by such person, on payment to him of the said salary, in respect of contributions in terms of the rules of the Parmed Medical Aid Scheme.

**(2) An amount so deducted shall be paid to the manager of the said medical aid scheme.**

**3. (1) The Parliamentary Medical Aid Scheme Act, 1974, is hereby repealed.**

## WET

**Om voorsiening te maak vir verpligte lidmaatskap van die Parmed Mediese Hulpskema van lede van sekere wettewende liggeme en van sekere ander persone; om voorsiening te maak vir die aftrekking van bydraes, betaalbaar aan genoemde mediese hulpskema, van die salaris aan sekere persone betaalbaar; om die Wet op die Parlementêre Mediese Hulpskema, 1974, te herroep; en om vir bykomstige aangeleenthede voorsiening te maak.**

**DAAR WORD BEPAAL** deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

**1. Elke persoon wat—**

- (a) terwyl hy nie 'n lid van of die Senaat of die Volksraad is nie, 'n Minister of 'n Adjunk-minister;
- (b) 'n Administrateur van 'n provinsie of die Administrateur van die gebied Suidwes-Afrika;
- (c) 'n lid van die Senaat, van die Volksraad, van die provinsiale raad van 'n provinsie of van die Wetgewende Vergadering van die gebied Suidwes-Afrika;
- (d) terwyl hy nie 'n lid van 'n provinsiale raad is nie, 'n lid van die uitvoerende komitee van 'n provinsie of, terwyl hy nie 'n lid van die Wetgewende Vergadering van die gebied Suidwes-Afrika is nie, 'n lid van die Uitvoerende Komitee van gemelde gebied,

is of word, is 'n lid van die Parmed Mediese Hulpskema, behoudens die reëls van daardie mediese hulpskema soos geregistreer ooreenkomsdig die bepalings van die Wet op Mediese Skemas, 1967 (Wet No. 72 van 1967), solank hy daardie amp of pos beklee.

**2. (1) Daar word maandeliks van die salaris betaalbaar aan iemand wat—**

- (a) 'n amp of pos in artikel 1 genoem, beklee; of
- (b) nadat hy opgehou het om so 'n amp of pos te beklee, onafgebroke 'n lid van die Parmed Mediese Hulpskema gebly het, en te eniger tyd nadat hy aldus opgehou het om so 'n amp of pos te beklee, 'n ander amp of pos beklee ten opsigte waarvan 'n salaris aan hom betaal word deur die Staat (met inbegrip van 'n provinsiale administrasie of die administrasie van die gebied Suidwes-Afrika),

Aftrekking van bydraes betaalbaar aan Parmed Mediese Hulpskema, van salaris.

'n bedrag afgetrek gelyk aan die bedrag wat deur so 'n persoon, by betaling aan hom van gemelde salaris, kragtens die reëls van die Parmed Mediese Hulpskema betaalbaar is ten opsigte van bydraes.

(2) 'n Bedrag aldus afgetrek, word aan die bestuurder van genoemde mediese hulpskema betaal.

**3. (1) Die Wet op die Parlementêre Mediese Hulpskema, Herroeping van Wet 82 van 1974, word hierby herroep.**

(2) Anything done, or deemed to have been done, under the provisions of the said Act, shall be deemed to have been done under the corresponding provisions of this Act.

**Short title and  
commencement.**

4. This Act shall be called the Parliamentary and Provincial Medical Aid Scheme Act, 1975, and shall be deemed to have come into operation on 1 April 1975.
