BY THE STATE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA.

No. 94, 1975.]

ASSUMPTION OF OFFICE OF STATE PRESIDENT.

WHEREAS, on 21 February 1975, I was declared to be duly elected as State President of the Republic of South Africa under the provisions of the Republic of South Africa Constitution Act, 1961, and have this day made and subscribed the prescribed Oath of Office in that capacity;

NOW, THEREFORE, I do hereby declare that I have this day assumed the said Office of State President of the Republic of South Africa, with all the powers, duties and functions pertaining thereto, of which notice is hereby given to all Ministers and officers of the said Republic, to South African citizens and all other persons whom it may concern and who are required to take due notice thereof.

GIVEN under my Hand and the Seal of the Republic of South Africa at Cape Town on this Nineteenth day of April, One thousand Nine hundred and Seventy-five.
