Act No. 65, 1975

APPROPRIATION ACT, 1975.

ACT

To apply an amount of money towards the service of the Republic for the financial year ending 31 March 1976.

*(Afrikaans text signed by the State President.)
(Assented to 20 June 1975.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Consolidated Revenue Fund charged with amounts of money as shown in column 1 of Schedule 1, on Revenue Account.

1. The Consolidated Revenue Fund of the Republic is hereby charged, on the Revenue Account, with such amounts of money as may be required for the service of the Republic for the financial year ending on 31 March 1976, as shown in column 1 of Schedule 1.

Consolidated Revenue Fund charged with amounts of money as shown in column 1 of Schedule 2, on Loan Account.

2. The Consolidated Revenue Fund of the Republic is further charged, on the Loan Account, with such amounts of money as may be required for the service of the Republic for the financial year ending on 31 March 1976, as shown in column 1 of Schedule 2.

Consolidated Revenue Fund charged with amounts of money as shown in column 1 of Schedule 3, on South-West Africa Account.

3. The Consolidated Revenue Fund of the Republic is further charged, on the South-West Africa Account, with such amounts of money as may be required for the service of the Republic for the financial year ending on 31 March 1976, as shown in column 1 of Schedule 3.

How money is to be applied.

4. The money appropriated by this Act shall be applied to the services detailed in the Schedules, and more particularly specified in the Estimates of Expenditure from the Revenue Account, the Loan Account and the South-West Africa Account, as submitted to and approved by Parliament, and to no other purpose.

Minister may approve variation.

5. With the approval of the Minister of Finance, a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head, of the same vote: Provided that the amounts appearing in column 2 of the Schedules shall not be exceeded, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedules.

Short title.

6. This Act shall be called the Appropriation Act, 1975.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Gekonsolideerde Inkomstefonds belas met bedrae geld soos uiteengesit in kolom 1 van Bylae 1, op Inkomsterekening.
2. Die Gekonsolideerde Inkomstefonds van die Republiek word verder op die Leningsrekening belas met die bedrae geld wat nodig is vir die diens van die Republiek vir die boekjaar wat op 31 Maart 1976 eindig, soos uiteengesit in kolom 1 van Bylae 2. Gekonsolideerde Inkomstefonds belas met bedrae geld soos uiteengesit in kolom 1 van Bylae 2, op Leningsrekening.
3. Die Gekonsolideerde Inkomstefonds van die Republiek word verder op die Suidwes-Afrikarekening belas met die bedrae geld wat nodig is vir die diens van die Republiek vir die boekjaar wat op 31 Maart 1976 eindig, soos uiteengesit in kolom 1 van Bylae 3. Gekonsolideerde Inkomstefonds belas met bedrae geld soos uiteengesit in kolom 1 van Bylae 3, op Suidwes-Afrika-rekening.
4. Die geld wat deur hierdie Wet beskikbaar gestel word, moet aangewend word vir die dienste in besonderhede in die Bylaes vermeld en meer omstandig uiteengesit in die Begrotings van Uitgawes uit die Inkomsterekening, die Leningsrekening en die Suidwes-Afrikarekening soos aan die Parlement voorgelê en deur die Parlement goedgekeur, en vir geen ander doel nie. Hoe die geld bestee moet word.
5. Met goedkeuring van die Minister van Finansies kan 'n besparing onder 'n subhoof van 'n begrotingspos aangewend word tot dekking van uitgawes bo die gemagtigde bedrag onder 'n ander subhoof, of van uitgawes onder 'n nuwe subhoof, van dieselfde begrotingspos: Met dien verstande dat die bedrae wat in kolom 2 van die Bylaes voorkom, nie oorskry mag word nie, en besparings daarop ewe min aangewend mag word vir 'n ander doel as dié waarvoor die geld hierby toegestaan word soos in gemelde Bylaes aangedui. Minister kan afwyking goedkeur.
6. Hierdie Wet heet die Begrotingswet, 1975. Kort titel.
