Kort titel.

**1.** Die volgende artikel word hierby na artikel 9 van die Wet op Reëling van Monopolistiese Toestande, 1955, ingevoeg:

„Toepassing 9A. Hierdie Wet en enige wysiging daarvan is van Wet in ook van toepassing in die gebied Suidwes-Afrika, Suidwes-Afrika. met inbegrip van die Oostelike Caprivi Zipfel.”;

**2.** Hierdie Wet heet die Wysigingswet op Reëling van Monopolistiese Toestande, 1976.

**REGULATION OF MONOPOLISTIC CONDITIONS AMENDMENT Act No. 23, 1976**  
**ACT, 1976**

# ACT

**To amend the Regulation of Monopolistic Conditions Act, 1955, to provide for the application of that Act in the territory of South West Africa; and for incidental matters.**

*(English text signed by the State President.)  
(Assented to 15 March 1976.)*

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

**1.** The following section is hereby inserted in the Regulation of Monopolistic Conditions Act, 1955, after section 9: Insertion of section 9A in Act 24 of 1955.

*"Application of Act 9A. This Act and any amendment thereof shall apply also in the territory of South West Africa, in South West Africa, including the Eastern Caprivi Zipfel."*

**2.** This Act shall be called the Regulation of Monopolistic Conditions Amendment Act, 1976. Short title.
