WYSIGINGSWET OP NASIONALE WELSYN, 1976.

WET

Tot wysiging van die Nasionale Welsynswet, 1965, ten einde voorsiening te maak vir die verlenging van die ampstermyn van lede van die raad, kommissies en streekswelsynsrade en die geldigheidsduur van nominasielyste.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Wet 79 van 1965.

1. Artikel 13 van die Nasionale Welsynswet, 1965, word hierby gewysig deur die volgende subartikel na subartikel (1) in te voeg:

„(1A) Die ampstermyn van 'n lid van die raad, 'n kommissie of streekswelsynsraad wat andersins op 30 Junie 1976 sou verstryk, kan deur die Minister verleng word vir 'n tydperk van hoogstens twee jaar of tydperke wat altesaam hoogstens twee jaar beloop.”.

artikel 15 van
Wet 79 van 1965.

2. Artikel 15 van die Nasionale Welsynswet, 1965, word hierby gewysig deur die volgende subartikel na subartikel (1) in te voeg:

„(1A) Die geldigheidsduur van 'n nominasielys wat andersins op 30 Junie 1976 sou verstryk, kan deur die Minister verleng word vir 'n tydperk van hoogstens twee jaar of tydperke wat altesaam hoogstens twee jaar beloop.”.

3. Hierdie Wet heet die Wysigingswet op Nasionale Welsyn, 1976.

NATIONAL WELFARE AMENDMENT ACT, 1976.

Act No. 44, 1976

ACT

To amend the National Welfare Act, 1965, so as to provide for the extension of the period of office of members of the board, commissions and regional welfare boards and the period of validity of nomination lists.

*(Afrikaans text signed by the State President.)
(Assented to 19 March 1976.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 13 of the National Welfare Act, 1965, is hereby amended by the insertion after subsection (1) of the following subsection: Amendment of section 13 of Act 79 of 1965.

“(1A) The period of office of a member of the board, a commission or regional welfare board which would otherwise expire on 30 June 1976, may be extended by the Minister for a period not exceeding two years or periods not exceeding two years in the aggregate.”.

2. Section 15 of the National Welfare Act, 1965, is hereby amended by the insertion after subsection (1) of the following subsection: Amendment of section 15 of Act 79 of 1965.

“(1A) The period of validity of any nomination list which would otherwise expire on 30 June 1976, may be extended by the Minister for a period not exceeding two years or for periods not exceeding two years in the aggregate.”.

3. This Act shall be called the National Welfare Amendment Act, 1976. Short title.
