Hierby word bekend gemaak dat die Staatspresident sy goedkeuring geheg het aan die onderstaande Wet wat hierby ter algemene inligting gepubliseer word:—

It is hereby notified that the State President has assented to the following Act which is hereby published for general information:—

No. 7 of 1977: Railways and Harbours Additional Appropriation Act, 1977.

Act No. 7, 1977

RAILWAYS AND HARBOURS ADDITIONAL APPROPRIATION ACT, 1977

ACT

To apply a further sum not exceeding three hundred and forty million six hundred and thirty-eight thousand rand from the Railway and Harbour Fund for the services of the railways and harbours for the year ending on 31 March 1977.

(Assented to 2 March 1977.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Railway and Harbour Fund charged with R340 638 000.

1. The Railway and Harbour Fund is hereby charged with such sums of money as may be required for the services of the railways and harbours of the Republic during the year ending on 31 March 1977 not exceeding in the whole for revenue services the sum of ninety-two million seven hundred and fifty-one thousand rand and for capital and betterment services the sum of two hundred and forty-seven million eight hundred and eighty-seven thousand rand in addition to the sums provided by the Railways and Harbours Appropriation Act, 1976 (Act No. 49 of 1976).

How money to be applied.

2. The money appropriated by this Act shall be applied to the purposes set forth in Schedules 1 and 2 to this Act, and more particularly specified in the Estimates of Additional Expenditure (R.P. 6—1977 and R.P. 7—1977) for the said year, as submitted to and approved by Parliament.

Minister may approve variations.

3. (1) With the approval of the Minister of Transport a saving on any of the heads set out in column 1 of Schedule 1 to this Act may be made available to meet any excess of expenditure on any other head appearing in column 1 of Schedule 1 to the Railways and Harbours Appropriation Act, 1976 (Act No. 49 of 1976), and similarly a saving on any one of the heads set out in column 1 of Schedule 2 to this Act may be made available to meet any excess of expenditure on any other head appearing in column 1 of Schedule 2 to the said Act.

(2) No excess shall be incurred on any sum appearing in column 2 of either Schedule 1 or Schedule 2 to this Act, and savings thereon shall not be available for any purpose other than that for which the money is hereby appropriated as indicated in those Schedules.

Railway lines and harbours under construction.

4. In the case of the service mentioned in Head No. 1 of Schedule 2 to this Act, the total expenditure on any railway line or harbour under construction shall not exceed the sum prescribed by law as the maximum sum which may be expended thereon.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Die Spoorweg- en Hawefonds word hierby belas met die bedrae geld wat nodig is vir die dienste van die spoorweë en hawens van die Republiek gedurende die jaar wat op 31 Maart 1977 eindig, maar gesamentlik ten bedrae van hoogstens twee-en-negentigmiljoen sewehonderd een-en-veertigduisend rand vir inkomstedienste en tweehonderd sewe-en-veertigmiljoen agthonderd sewe-en-tagtigduisend rand vir kapitaal- en verbeteringsdienste bo en behalwe die bedrae waarvoor voorsiening gemaak is deur die Spoorweg- en Hawebegrotingswet, 1976 (Wet No. 49 van 1976).

2. Die geld deur hierdie Wet beskikbaar gestel, moet aangewend word vir die doeleindes vermeld in Bylaes 1 en 2 by hierdie Wet en nader omskrywe in die Begroting van Addisionele Uitgawe (R.P. 6—1977 en R.P. 7—1977) vir genoemde jaar, soos aan die Parlement voorgelê en deur hom goedgekeur.

3. (1) Met die goedkeuring van die Minister van Vervoer kan 'n besparing op die een of die ander van die hoofde aangetoon in kolom 1 van Bylae 1 by hierdie Wet, beskikbaar gestel word vir dekking van 'n oorskryding van die uitgawe op 'n ander hoof wat voorkom in kolom 1 van Bylae 1 by die Spoorweg- en Hawebegrotingswet, 1976 (Wet No. 49 van 1976), en kan 'n besparing op die een of die ander van die hoofde aangetoon in kolom 1 van Bylae 2 by hierdie Wet, insgelyks beskikbaar gestel word vir dekking van 'n oorskryding van die uitgawe op 'n ander hoof wat voorkom in kolom 1 van Bylae 2 by genoemde Wet.

(2) Geen bedrag wat voorkom in kolom 2 van of Bylae 1 of Bylae 2 by hierdie Wet mag oorskry word nie, en besparings daarop mag vir geen ander doel as dié waarvoor die geld hierby beskikbaar gestel word, soos aangetoon in daardie Bylaes, aangewend word nie.

4. In die geval van die diens genoem in Hoof No. 1 van Bylae 2 by hierdie Wet, mag die gesamentlike uitgawe aan 'n spoorlyn of hawe wat in aanbou is, nie meer bedra as die bedrag wat deur 'n wet vasgestel is as die maksimum bedrag wat daaraan bestee mag word nie.

Act No. 7, 1977 RAILWAYS AND HARBOURS ADDITIONAL APPROPRIATION ACT, 1977

Increase in expenditure on authorized line or harbour.

5. Notwithstanding anything to the contrary contained in any law authorizing the construction and equipment of any line of railway or harbour mentioned in column 1 of Schedule 4 to this Act, the sum mentioned in column 2 of that Schedule (being the sum prescribed by law as the maximum sum that may be expended on that line or harbour) shall be increased to the sum set out in column 3 of that Schedule.

Sources of financing.

6. The appropriation of R125 600 000 foreign loans for capital and betterment services as provided for in Schedule 3 to the Railways and Harbours Appropriation Act, 1976 (Act No. 49 of 1976), shall be provided by means of foreign loans and from other sources.

Sources from which money appropriated shall be provided.

7. The money appropriated by this Act for capital and betterment services shall be provided from the sources set out in Schedule 3 to this Act.

Short title.

8. This Act shall be called the Railways and Harbours Additional Appropriation Act, 1977.

5. Ondanks andersluidende bepalings in 'n wet wat magtiging verleen vir die aanleg en uitrusting van 'n spoorlyn of hawe vermeld in kolom 1 van Bylae 4 by hierdie Wet, word die bedrag vermeld in kolom 2 van daardie Bylae, naamlik die bedrag by wet vasgestel as die maksimum bedrag wat aan daardie lyn of hawe bestee mag word, vermeerder tot dié bedrag wat in kolom 3 van daardie Bylae aangegee word. Vermeerdering van uitgawe aan goegekeurde spoorlyn of hawe.
6. Die beskikbaarstelling van R125 600 000 by wyse van buitelandse lenings vir kapitaal- en verbeteringsdienste soos in Bylae 3 by die Spoorweg- en Hawebegrotingswet, 1976 (Wet No. 49 van 1976), voorsien is, word deur middel van buitelandse lenings en uit ander bronne verskaf. Bronne van finansiering.
7. Die geld wat deur hierdie Wet vir kapitaal- en verbeteringsdienste beskikbaar gestel word, word uit die in Bylae 3 by hierdie Wet vermelde bronne verskaf. Bronne waaruit beskikbaargestelde geld verskaf moet word.
