No. 30 of 1977: Constitution Amendment Act, 1977.

Act No. 30, 1977**CONSTITUTION AMENDMENT ACT, 1977.**

ACT

To amend the Republic of South Africa Constitution Act, 1961, so as to provide for the rendering of assistance by provinces and local authorities to other provinces and the territory of South West Africa.

(Assented to 22 March 1977.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of section 84 of Act 32 of 1961, as amended by section 37 of Act 47 of 1963, section 36 of Act 61 of 1965 and section 4 of Act 61 of 1972.

Short title.

1. Section 84 of the Republic of South Africa Constitution Act, 1961, is hereby amended by the substitution for paragraph (fA) of subsection (1) of the following paragraph:

“(fA) the assistance which a province or an institution or body contemplated in paragraph (f) may, with the approval of the State President, render to any other state, territory, province or the territory of South West Africa;”.

2. This Act shall be called the Constitution Amendment Act, 1977.

WYSIGINGSWET OP DIE GRONDWET, 1977.

Tot wysiging van die Grondwet van die Republiek van Suid-Afrika, 1961, ten einde voorsiening te maak vir hulpverlening deur provinsies en plaaslike owerhede aan ander provinsies en die gebied Suidwes-Afrika.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 84 van die Grondwet van die Republiek van Suid-Afrika, 1961, word hierby gewysig deur paragraaf (fA) van subartikel (1) deur die volgende paragraaf te vervang:
„(fA) die hulp wat 'n provinsie of 'n instelling of liggaam in paragraaf (f) beoog, met die goedkeuring van die Staatspresident, aan 'n ander staat, gebied, provinsie of die gebied Suidwes-Afrika kan verleen;”.
2. Hierdie Wet heet die Wysigingswet op die Grondwet, 1977. Kort titel.
