Act No. 32, 1977

PROVINCIAL AFFAIRS AMENDMENT ACT, 1977.

ACT

To amend the Provincial Affairs Act, 1972, so as to extend the period within which town-planning schemes are to comply with the requirement as to bilingualism.

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of
section 5 of
Act 61 of 1972.

1. Section 5 of the Provincial Affairs Act, 1972, is hereby amended by the substitution for subsection (3) of the following subsection:

“(3) As from a date eight years from the commencement of this section any town-planning scheme referred to in subsection (2) shall cease to be valid unless it is in both official languages.”.

Short title.

2. This Act shall be called the Provincial Affairs Amendment Act, 1977.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 5 van die Wet op Provinsiale Aangeleenthede, 1972, word hierby gewysig deur subartikel (3) deur die volgende subartikel te vervang:

Wysiging van
artikel 5 van
Wet 61 van 1972.

„(3) Vanaf 'n datum agt jaar na die inwerkingtreding van hierdie artikel hou 'n in subartikel (2) bedoelde dorpsaanlegskema op om geldig te wees tensy dit in albei amptelike tale is.”.

2. Hierdie Wet heet die Wysigingswet op Provinsiale Aangeleenthede, 1977. Kort titel.
