Act No. 60, 1977SCIENTIFIC RESEARCH COUNCIL
AMENDMENT ACT, 1977.

ACT

To amend the Scientific Research Council Act, 1962, so as to empower the council to undertake scientific and industrial research in any territory outside the Republic in certain circumstances; and to provide for matters connected therewith.

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Insertion of
section 4A in
Act 32 of 1962.

1. The Scientific Research Council Act, 1962, is hereby amended by the insertion after section 4 of the following section:

"Exercising
of powers in
territories
outside the
Republic.

4A. (1) The council may, at the request or with the prior approval of the Minister, undertake scientific and industrial research in any territory outside the Republic on behalf of any person (including any government or administration) in any such territory.

(2) Subject to the provisions of subsection (3), the provisions of this Act shall, in so far as they can be applied, apply *mutatis mutandis* in connection with the exercising by the council of its powers in terms of this section as if the territory in which it so exercises its powers is within the Republic.

(3) Notwithstanding anything to the contrary in this Act contained, the terms and conditions on which the council may undertake research in terms of subsection (1), shall be such as may be mutually agreed upon between the council and the person (including any government or administration) on whose behalf research is to be undertaken, and approved by the Minister.

(4) The Minister may with the concurrence of the Minister of Finance indemnify the council against any losses it may incur consequent on any act or omission of the government or administration of any territory outside the Republic.”.

Short title.

2. This Act shall be called the Scientific Research Council Amendment Act, 1977.

**WYSIGINGSWET OP DIE WETENSKAPLIKE
NAVORSINGSRAAD, 1977.**

Wet No. 60, 1977

WET

Tot wysiging van die Wet op die Wetenskaplike Navorsingsraad, 1962, ten einde die raad die bevoegdheid te verleen om onder sekere omstandighede wetenskaplike en industriële navorsing in enige gebied buite die Republiek te doen; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Die Wet op die Wetenskaplike Navorsingsraad, 1962, word hierby gewysig deur na artikel 4 die volgende artikel in te voeg:

Invoeging van artikel 4A in Wet 32 van 1962.

„Uitvoering van bevoegdhede in gebiede buiten die Republiek.

4A. (1) Die raad kan op versoek van of met die voorafverkreeë goedkeuring van die Minister wetenskaplike en industriële navorsing in enige gebied buiten die Republiek doen namens enigiemand (met inbegrip van enige regering of administrasie) in sodanige gebied.

(2) Behoudens die bepalings van subartikel (3) is die bepalings van hierdie Wet, vir sover hulle toegepas kan word, *mutatis mutandis* van toepassing in verband met die uitvoering deur die raad van sy bevoegdhede ingevolge hierdie artikel asof die gebied waarin hy sy bevoegdhede aldus uitoefen binne die Republiek is.

(3) Ondanks andersluidende bepalings van hierdie Wet, is die bedinge en voorwaardes waarop die raad ingevolge subartikel (1) navorsing kan doen, dié waarop daar onderling tussen die raad en die persoon (met inbegrip van enige regering of administrasie) namens wie navorsing gedoen gaan word, ooreengekomm word en wat deur die Minister goedgekeur word.

(4) Die Minister kan met die instemming van die Minister van Finansies die raad vrywaar teen verliese wat die raad mag ly as gevolg van 'n handeling of versuum van die regering of administrasie van 'n gebied buiten die Republiek.”.
