UNIVERSITY OF DURBAN-WESTVILLE  
AMENDMENT ACT, 1977.**ACT**

**To amend the University of Durban-Westville Act, 1969, so as to further regulate the admission as students of persons not classified as members of the Indian Group; and to provide for incidental matters.**

*(Afrikaans text signed by the State President.)  
(Assented to 11 July 1977.)*

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Repeal of  
section 21 of  
Act 49 of 1969.

Substitution of  
section 22 of  
Act 49 of 1969.

Short title and  
commencement.

**1.** Section 21 of the University of Durban-Westville Act, 1969 (hereinafter referred to as the principal Act), is hereby repealed.

**2.** The following section is hereby substituted for section 22 of the principal Act:

“Admission as a student of any person not classified as a member of the Indian group. **22.** Notwithstanding the provisions of subsection (3) of section 2 the council may, with the concurrence of the Minister and on the conditions determined by the Minister, approve the admission as a student of the University of any person not classified as a member of the Indian Group as contemplated in that subsection.”.

**3.** This Act shall be called the University of Durban-Westville Amendment Act, 1977, and shall come into operation on 1 January 1978.

**Tot wysiging van die Wet op die Universiteit van Durban-Westville, 1969, ten einde die toelating as studente van persone wat nie as lede van die Indiërgroep geklassifiseer is nie, verder te reël; en om vir bykomstige aangeleenthede voorsiening te maak.**

(Goedgekeur op 11 Julie 1977.)*

**DAAR WORD BEPAAL** deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

**1.** Artikel 21 van die Wet op die Universiteit van Durban-Westville, 1969 (hieronder die Hoofwet genoem), word hierby herroep. Herroeping van artikel 21 van Wet 49 van 1969.

**2.** Artikel 22 van die Hoofwet word hierby deur die volgende artikel vervang: Vervanging van artikel 22 van Wet 49 van 1969.

„Toelating as student van iemand wat nie as lid van die Indiërgroep geklassifiseer is nie. **22.** Ondanks die bepalings van subartikel (3) van artikel 2 kan die raad, met die instemming van die Minister en op die voorwaardes wat die Minister bepaal, die toelating van iemand wat nie as 'n lid van die Indiërgroep geklassifiseer is soos in daardie subartikel bedoel nie, as 'n student van die Universiteit goedkeur.”

**3.** Hierdie Wet heet die Wysigingswet op die Universiteit van Durban-Westville, 1977, en tree op 1 Januarie 1978 in werking. Kort titel en inwerkingtreding.
