**Act No. 2, 1979****ADVERTISING ON ROADS AND RIBBON DEVELOPMENT  
AMENDMENT ACT, 1979.****GENERAL EXPLANATORY NOTE:****I**

**ACT**

**To amend the Advertising on Roads and Ribbon Development Act, 1940, relating to the definition of "public road"; the erection of buildings and other structures near certain roads; and the metrication of certain distances; and to provide for incidental matters.**

(Assented to 6 March 1979.)*

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 21 of 1940, as amended by section 11 of Act 22 of 1944, section 1 of Act 28 of 1952, section 1 of Act 16 of 1962 and section 29 of Act 54 of 1971.

Amendment of section 8 of Act 21 of 1940, as substituted by section 1 of Act 16 of 1966 and amended by section 29 of Act 54 of 1971.

Amendment of section 9A of Act 21 of 1940, as inserted by section 2 of Act 6 of 1976.

1. Section 1 of the Advertising on Roads and Ribbon Development Act, 1940 (hereinafter referred to as the principal Act), is hereby amended—

- (a) by the substitution for the definition of "public road" of the following definition:  
“‘public road’ means any road **【which the public has the right to use】** declared a public road in terms of any law, but does not include a national road as defined in the National Roads Act, 1971;”;
- (b) by the substitution for the expression “one hundred Cape feet” where it occurs in the definition of “road”, of the expression “32 m”. 15

2. Section 8 of the principal Act is hereby amended by the substitution for the expression “two hundred yards” where it occurs in subsection (1), of the expression “200 m”.

3. Section 9A of the principal Act is hereby amended by the substitution for paragraph (a) of subsection (1) of the following paragraph:

- “(a) on land situated within a distance of 500 m from the intersection of the centre line of—  
(i) a building restriction road with the centre line of another building restriction road or any other road; 25  
(ii) any road with the boundary of any building restriction road with which it links up,  
except a national road as defined in the National Roads Act, 1971 (Act No. 54 of 1971), erect any structure or any other thing which is attached to the land on which it stands, whether or not it forms part of that land;”.

## WET

Tot wysiging van die Wet op Adverteer Langs en Toebou van Paaie, 1940, betreffende die omskrywing van „publieke pad”; die oprigting van bouwerke en ander strukture naby sekere paaie; en die metrisering van sekere afstande; en om vir bykomstige aangeleenthede voorsiening te maak.

(Goedgekeur op 6 Maart 1979.)

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:

1. Artikel 1 van die Wet op Adverteer Langs en Toebou van Wysiging van  
5 Paaie, 1940 (hieronder die Hoofwet genoem), word hierby artikel 1 van  
gewysig— artikel 1 van  
Wet 21 van 1940,  
soos gewysig deur  
artikel 11 van  
Wet 22 van 1944,  
artikel 1 van  
Wet 28 van 1952,  
artikel 1 van  
Wet 16 van 1962  
en artikel 29 van  
Wet 54 van 1971.
- (a) deur die omskrywing van „publieke pad”, deur die volgende omskrywing te vervang:  
„publieke pad”, 'n pad wat **[die publiek die reg het om te gebruik]** ingevolge enige wet tot 'n openbare pad verklaar is, maar nie ook 'n nasionale pad soos omskryf in die Wet op Nasionale Paaie, 1971, nie.”;
- 10 (b) deur die uitdrukking „honderd Kaapse voet” waar dit in die omskrywing van „pad” voorkom, deur die uitdrukking „32 m” te vervang.
2. Artikel 8 van die Hoofwet word hierby gewysig deur die Wysiging van  
uitdrukking „tweehonderd jaarts” waar dit in subartikel (1) artikel 8 van  
voorkom, deur die uitdrukking „200 m” te vervang. artikel 8 van  
Wet 21 van 1940,  
soos vervang deur  
artikel 1 van  
Wet 16 van 1966  
en gewysig deur  
artikel 29 van  
Wet 54 van 1971.
- 20 3. Artikel 9A van die Hoofwet word hierby gewysig deur Wysiging van  
paragraaf (a) van subartikel (1) deur die volgende paragraaf te vervang:  
„(a) op grond geleë binne 'n afstand van 500 m vanaf die kruising van die middellyn van—
- 25 (i) 'n boubeperkingspad met die middellyn van 'n ander boubeperkingspad of enige ander pad;  
(ii) 'n pad met die grens van 'n boubeperkingspad waarby dit aansluit,  
30 behalwe 'n nasionale pad soos omskryf in die Wet op Nasionale Paaie, 1971 (Wet No. 54 van 1971), 'n bouwerk of enigets anders wat verbonden is aan die grond waarop dit staan, ongeag of dit deel uitmaak van daardie grond of nie, oprig nie.”.

**ADVERTISING ON ROADS AND RIBBON DEVELOPMENT AMENDMENT ACT, 1979.**

**4.** Section 11 of the principal Act is hereby amended by the substitution for the expression "three hundred Cape feet" wherever it occurs, of the expression "95 m".

**5.** This Act shall be called the Advertising on Roads and Ribbon Development Amendment Act, 1979.
