PARLIAMENTARY JOINT COMMITTEE ON THE
CONSTITUTION

It is hereby notified for general information that the Senate and the House of Assembly, on the motion of the Honourable the Minister of the Interior and Immigration, have referred the consideration of the introduction of a new Constitution for the Republic of South Africa to a Joint Committee of both Houses for inquiry and report, the Committee to have power to take evidence and call for papers and to submit legislation.

The Joint Committee desires all persons and institutions who wish to submit representations on the subject of the Committee's inquiry to submit such representations, in writing, or an application to submit such representations, to the Committee by 30 June 1979.
