PUBLIKASIES OF VOORWERPE

Die Appèlaad oor Publikasies het kragtens artikel 15 (6) (d) van die Wet op Publikasies, 1974, soos gewysig, beslis dat die ondergenoemde grammofoonplaat nie ongewens is nie en het die beslissing van 'n komitee bedoel in artikel 4 van genoemde Wet dat genoemde grammofoonplaat binne die bedoeling van artikel 47 (2) (b) van genoemde Wet ongewens is, ter syde gestel en het die volgende voorwaardes opgelê:

Die verspreiding van die plaat AMLS 68343 word goedgekeur onderhewig aan die voorwaarde dat die Christus-figuur op die agterkant van die plaatomslag sowel as op die libretto verwijder moet word en dat die volgende aanhaling van Chris de Burgh op die agterkant van die plaatomslag, of op die libretto gedruk moet word: "Spanish Train is about the endless struggle between good and evil and why good should win".

PUBLICATIONS OR OBJECTS

The Publication Appeal Board in terms of section 15 (6) (d) of the Publications Act, 1974, as amended, decided that the undermentioned gramophone record is not undesirable and set aside the decision of a committee referred to in section 4 of the said Act that the said gramophone record is undesirable within the meaning of section 47 (2) (b) of the said Act and imposed the following conditions:

The distribution of the record AMLS 68343 is permitted subject to the condition that the production of the Christ figure on the back cover and on the libretto be removed, and further that the following quotation of Chris de Burgh be printed on the back cover or libretto: "Spanish Train is about the endless struggle between good and evil and why good should win".
