„(c) die tarief van hof- en ander gelde (behalwe **[advokaatsgelde]** advokaats- en prokureursgelde) en kostebevele in verband met verrigtinge van 'n vergoedingshof;”.

EXPROPRIATION AMENDMENT ACT, 1980

ACT

To amend the Expropriation Act, 1975, relating to the tariffs of court and other fees in connection with the proceedings before compensation courts.

(Assented to 18 March 1980.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 25 of the Expropriation Act, 1975, is hereby Amendment of section 25 of Act 63 of 1975, as amended by section 3 of Act 3 of 1978.
5 amended by the substitution for paragraph (c) of subsection (1) of the following paragraph:
“(c) the tariff of court and other fees (excluding advocates’ and attorneys’ fees) and orders as to costs in connection Act 3 of 1978.
with proceedings before a compensation court;”.
