PROCLAMATION

*by the State President of the Republic of
 South Africa*

No. 91, 1980

DECLARATION THAT THE PROVISIONS OF THE RENT CONTROL ACT, 1976, WILL APPLY UNDER CERTAIN CIRCUMSTANCES TO CERTAIN DWELLINGS, GARAGES AND PARKING SPACES, OCCUPIED OR USED FOR THE FIRST TIME AFTER THE 20TH DAY OF OCTOBER 1949 AND BEFORE THE FIRST DAY OF JUNE 1966

In terms of the powers vested in me by section 52 (1) of the Rent Control Act, 1976 (Act 80 of 1976), I hereby declare that the provisions of the said Act shall apply *mutatis mutandis* in respect of—

(a) dwellings; and

(b) garages and parking spaces situate on land forming part of land occupied by or being used in connection with a building wholly or predominantly occupied for residential purposes or on any such space within any such building;

which were occupied or used for the first time after the 20th day of October 1949 and before the 1st day of June 1966 and situated anywhere in any area for which a rent board has been constituted and which are occupied on the date of issue hereof by a lessee as defined in paragraph (vii) of section 1 of the Rent Control Act, 1976 (Act 80 of 1976), who falls within the income categories as determined in terms of section 19 (1) (a) of the Housing Act, 1966 (Act 4 of 1966): Provided that the provisions of the said Rent Control Act shall only be applicable to a dwelling occupied for the first time after the 20th of October 1949 and before the 1st day of June 1966 as long as the lessee remains in occupation of such dwelling which he occupied on the date of this Proclamation, and for as long as his income does not exceed the income as defined in the Proclamation.

VERKLARING DAT DIE BEPALINGS VAN DIE WET OP HUURBEHEER, 1976, VAN TOEPASSING IS ONDER SEKERE OMSTANDIGHEDEN OP SEKERE WONINGS, MOTORHUISE OF MOTORSTAAANPLEKKE WAT VIR DIE EERSTE KEER NA DIE 20STE DAG VAN OKTOBER 1949 EN VOOR DIE 1STE DAG VAN JUNIE 1966 GEOKKUPPEER OF GEBRUIK IS

Kragtens die bevoegdheid my verleen by artikel 52 (1) van die Wet op Huurbeheer, 1976 (Wet 80 van 1976), verklaar ek hierby dat die bepalings van die genoemde Wet *mutatis mutandis* van toepassing is ten opsigte van—

(a) wonings; en

(b) motorhuise en motorstaanplekke geleë op grond wat deel uitmaak van grond wat geokkuppeer word deur of gebruik word in verband met 'n gebou geheel en al of hoofsaaklik vir woondoeleindes geokkuppeer of op enige plek binne enige sodanige gebou;

wat vir die eerste keer na die 20ste dag van Oktober 1949 en voor die 1ste dag van Junie 1966 geokkuppeer of gebruik is en geleë is op enige plek in enige gebied waarvoor 'n huurraad ingestel is en wat op datum van uitvaardiging hiervan geokkuppeer is deur 'n huurder soos omskryf in paragraaf (v) van artikel 1 van die Wet op Huurbeheer, 1976 (Wet 80 van 1976), wat binne die inkomstekategorieë val soos bepaal ingevolge artikel 19 (1) (a) van die Behuisingwet, 1966 (Wet 4 van 1966): Met dien verstande dat die bepalings van die gemelde Wet op Huurbeheer slegs van toepassing sal wees op 'n woning wat vir die eerste keer na die 20ste dag van Oktober 1949 en voor die 1ste dag van Junie 1966 geokkuppeer is vir solank die huurder daardie woning bly bewoon wat hy op datum van uitvaardiging van hierdie proklamasie bewoon het en vir solank sy inkomste nie die inkomste soos in die proklamasie omskryf, oorskry nie.
