1. Vanaf die inwerkingtreding van hierdie Wet heet die kommissie ingestel deur artikel 4 van die Staatsdienswet, 1957, 5 die Kommissie vir Administrasie, en vanaf sodanige inwerkingtreding word enige verwysing in daardie Wet of in enige ander wet of in enige dokument na die Staatsdienskommissie geag 'n verwysing na die Kommissie vir Administrasie te wees.

2. Hierdie Wet heet die Staatsdienswysigingswet, 1980. 10

ACT

To amend the Public Service Act, 1957, so as to alter the name of the commission established by section 4 of that Act; and to provide for incidental matters.

*(Afrikaans text signed by the State President.)
(Assented to 23 May 1980.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. As from the commencement of this Act the commission established by section 4 of the Public Service Act, 1957, shall be known as the Commission for Administration, and as from such commencement any reference in that Act or in any other law or in any document to the Public Service Commission shall be deemed to be a reference to the Commission for Administration.
