SCHEDULE**1. DEFINITIONS**

In these regulations, unless the context otherwise indicates—
 “Administration Board” or “Board” means the Administration Board for the Northern Cape Area established under the provisions of section 2 of the Black Affairs Administration Act, 1971 (Act 45 of 1971);
 “Residential Area Regulations” means the Regulations Governing the Control and Supervision of an Urban Black Residential Area and Relevant Matters, as promulgated by Government Notice R.1036 of 14 June 1968 and made applicable to all urban areas by Government Notice R.1267 of 26 July 1968;
 “site rent” means an amount calculated on—
 (a) costs and charges in respect of—
 (i) administration;
 (ii) health services;
 (iii) interest payable on and redemption payments of a loan entered into for the financing of the purchase of land situated within the administration area of the administration board on which a Black residential area has been laid out;
 (iv) stormwater drainage;
 (v) street lighting;
 (vi) streets;
 (vii) welfare services;
 (viii) sport and recreation;
 (ix) survey of sites;
 (b) the cost of providing accommodation for educational purposes; and
 any expression to which a meaning has been assigned in the Residential Area Regulations shall bear the meaning so assigned thereto.

2. CHARGES PAYABLE AND PAYMENT THEREOF

The rents, charges and other moneys payable by a person residing or any trader carrying on business in any Black residential area within the administration area of the Administration Board shall be as set out in Annexures A to X, both inclusive, of the Schedule and shall be paid at the office of the Superintendent of the Black residential area in which such person resides or such trader is carrying on business, as the case may be.

3. CHARGES PAYABLE IN RESPECT OF EACH MONTH OR MONTHLY

Site rent, sewerage, night soil removal, refuse removal, accommodation permit, accommodation charges, water and the levy payable for the supply of electricity for each month or part thereof, and the charges payable per unit of electricity used shall be payable monthly.

4. REPEAL OF LAWS

Government Notice 628 of 30 March 1979 is hereby withdrawn.
