## **BLACK ADMINISTRATION AMENDMENT ACT, 1981**

## **GENERAL EXPLANATORY NOTE:**

Words underlined with solid line indicate insertions in existing enactments.

## ACT

To amend the Black Administration Act, 1927, so as to exclude certain persons from the jurisdiction of a Commissioner's Court; and to provide for matters connected therewith.

(English text signed by the State President.)  
(Assented to 3 March 1981.)

**B**E IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Amendment of section 10 of Act 38 of 1927, as amended by section 5 of Act 9 of 1929, section 3 of Act 21 of 1943, section 21 of Act 56 of 1949, section 3 of Act 79 of 1957, section 2 of Act 70 of 1974 and section 1 of Act 12 of 1978.

### Short title.

1. Section 10 of the Black Administration Act, 1927, is hereby amended by the addition to the proviso to subsection (1) of the following paragraph:

“(f) any person who is immune from the jurisdiction of the courts of the Republic in terms of section 2 or 2A of the Diplomatic Privileges Act, 1951 (Act No. 71 of 1951), and who is not a South African citizen, is a party.”

2. This Act shall be called the Black Administration Amendment Act, 1981.
