ACT

To amend the Regulation of Functions of Officers in the Public Service Act, 1980, so as to make different provision as to the duration of that Act.

*(English text signed by the State President.)
(Assented to 3 March 1981.)*

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Substitution of section 2 of Act 19 of 1980.

1. The following section is hereby substituted for section 2 of the Regulation of Functions of Officers in the Public Service Act, 1980:

"Duration of this Act.

2. This Act shall cease to have effect on **[1 March 1981]** a date fixed by the State President by proclamation in the *Gazette*.".

Short title.

2. This Act shall be called the Regulation of Functions of Officers in the Public Service Amendment Act, 1981.
