**NUWE REËLS EN WYSIGINGS VAN BESTAANDE REËLS**

Onderstaande nuwe reëls en wysigings tot die bestaande reëls van die Prokureursorde van die Oranje-Vrystaat, is deur die Prokureursorde aange- neem en na oorlegpleging van die Raad met die Regter-President van die Oranje-Vrystaatse Proviniale Afdeling van die Hooggereghof van Suid- Afrika, deur die Hoofregter van Suid-Afrika goedgekeur, kragtens die bepalinge van artikel 74 van die Wet op Prokureurs, 1979 (Wet 53 van 1979), soos gewysig.

**1. NUWE REËL 13 (h), INGEVOEG TE WORD NA REËL 13 (g)**

13 (h) Die Raad het die reg om namens die Orde, die interprovinciale verdeling van aktes- en deeltitelgeld te bepaal.

**2. NUWE REËL 15 (g), INGEVOEG TE WORD NA REËL 15 (f)**

15 (g) Die Raad bepaal die maksimum heffingsgeld wat 'n lid mag vra vir die reëling en heffing van finansiering.

**3. NUWE REËL 17 (32), INGEVOEG TE WORD NA REËL 17 (31)**

17 (32) Die onredelike versuum om 'n afdwingbare eis van 'n medepraktisy wat voortspruit uit 'n opdrag wat aan laasgenoemde toevertrou is, te bepaal.

**4. NUWE REËL 17 (33), INGEVOEG TE WORD NA REËL 17 (32)**

17 (33) Behoudens die reg van 'n party tot die betrokke saak om teenwoordig te wees, laat 'n lid nie toe nie dat die taksasie van 'n kosterekening waargeneem word deur enige ander persoon as 'n persoon in reël 17 (33) (a) vermeld.

(a) Die taksasie van 'n kosterekening, mag slegs waargeneem word deur 'n lid wat die rekening voorlê of ten behoeve van wie die rekening voorge- lê word, of deur sy venoot of heeltydse werknemer wat 'n lid is of 'n klerk onder leerkontrak is wat geregtig is om te verskyn ingevolge artikel 8 (1) van die Wet, of deur sy korrespondent of sy korrespondent se heeltydse werknemer wat 'n lid is of 'n klerk onder leerkontrak soos voormeld, welke persoon in elke geval met die onderwerp van die taksasie vertrou is; Met dien verstande dat eersvermelde lid of sy korrespondent, na gelang van die geval, volle verantwoordelikheid vir die inhoud van die rekening wat voorgelê word en vir die taksasie aanvaar.

**THE LAW SOCIETY OF THE ORANGE FREE STATE**

**NEW RULES AND AMENDMENTS TO EXISTING RULES**

The undermentioned new rules and amendments to the existing rules of the Law Society of the Orange Free State have been made by the Society and after consultation of the Council with the Judge-President of the Orange Free State Provincial Division of the Supreme Court of South Africa, have been approved by the Chief Justice of South Africa in terms of section 74 of the Attorneys Act, 1979 (Act 53 of 1979), as amended.

**1. NEW RULE 13 (h), TO BE INSERTED AFTER RULE 13 (g)**

13 (h) The Council has the right on behalf of the Society, to determine the interprovincial division of deeds and sectional title fees.

**2. NEW RULE 15 (g), TO BE INSERTED AFTER RULE 15 (f)**

15 (g) The Council fixes the maximum raising fee a member may charge for the arrangement and raising of finance.

**3. NEW RULE 17 (32), TO BE INSERTED AFTER RULE 17 (31)**

17 (32) Unreasonable failure to pay an enforceable claim of a practitioner in respect of work entrusted to such practitioner.

**4. NEW RULE 17 (33), TO BE INSERTED AFTER NEW RULE 17 (32)**

17 (33) Subject to the right of a party to the matter concerned to be present, a member shall not permit the taxation of a bill of costs to be handled by any person other than a person referred to in rule 17 (33) (a).

(a) The taxation of a bill of costs may only be handled by the member presenting the bill or on whose behalf the bill is presented or by his partner or full-time employee, being a member or an articled clerk entitled to appear in terms of section 8 (1) of the Act, or by his correspondent or correspondent's full-time employee, being a member or an articled clerk as aforesaid and being, in each case a person familiar with the subject matter of the taxation; provided that the first-mentioned member or his correspondent, as the case may be, shall assume full responsibility for the contents of the bill submitted and for the taxation.
