AMENDED**

The Chairman of the Publications Appeal Board has decided under section 13 (3) (a) of the Publications Act, 1974, to suspend the decision of a committee under section 11 (2) of the said Act that the publication *Scope* of 8 January 1982 is undesirable until the Appeal Board has determined the appeal by Republican Press against that decision.
