#### GELDE BETAALBAAR EN BETALING DAARVAN

2. Die huurgelde, vorderings en ander gelde betaalbaar deur ’n persoon woonagtig in ’n Swart woongebied binne die administrasiegebied van die Administrasieraad, is soos in Aanhangsels A tot V van die Bylae uiteengesit en word betaal by die kantoor van die Superintendent van die Swart woongebied waarin sodanige persoon woon.

#### HUURGELD TEN OPSIGTE VAN PERSELE EN WONINGS EN HUISVESTINGSGELDE TEN OPSIGTE VAN SWART TEHUISE

3. Die gelde hieronder bepaal is ten opsigte van elke maand of deel daarvan betaalbaar—

- (a) vir die verhuring van ’n perseel ten opsigte waarvan ’n perseelpermit uitgereik is ingevolge die bepaling van regulasie 6 van Hoofstuk 2 van die Woongebiedregulasies;
- (b) vir die verhuring van ’n perseel ten opsigte waarvan ’n sertifikaat van bewoning uitgereik is ingevolge die bepaling van regulasie 8 van Hoofstuk 2 van die Woongebiedregulasies;
- (c) vir die verhuring van ’n woning ingevolge die bepaling van regulasie 7 van Hoofstuk 2 van die Woongebiedregulasies; en
- (d) vir huisvesting in ’n Swart tehuis ingevolge die bepaling van regulasie 13 van Hoofstuk 7 van die Woongebiedregulasies.

#### HUURGELD TEN OPSIGTE VAN HANDELSPERSELE

4. Die gelde hieronder bepaal ten opsigte van handelspersele, is vir elke maand of deel daarvan deur elke handelaar betaalbaar.

#### GELDE WAT TEN OPSIGTE VAN ELKE MAAND OF MAANDELIKS BETAALBAAR IS

5. Gelde ten opsigte van riolering, nagvuilverwydering, vullisverwydering, verblyfpermitte, water en die heffing betaalbaar vir die lewering van elektrisiteit is ten opsigte van elke maand of deel daarvan betaalbaar, en die gelde betaalbaar per eenheid elektrisiteit verbruik, is maandeliks betaalbaar.

“Residential Area Regulations” means the Regulations Governing the Control and Supervision of an Urban Black Residential Area and Relevant Matters, promulgated by Government Notice R. 1036 of 14 June 1968 and made applicable to all urban areas by Government Notice R. 1267 of 26 July 1968, as amended;

“site rent” means an amount calculated on costs and moneys in respect of—

- (i) administration;
- (ii) health services;
- (iii) interest payable on and redemption payments of a loan entered into for the financing of the purchase of land situated within the administration area of the Administration Board on which a Black residential area has been laid out;
- (iv) storm water drainage;
- (v) street lighting;
- (vi) streets;
- (vii) welfare services;
- (viii) sport and recreation;
- (ix) provision of accommodation for educational purposes;
- (x) water;
- (xi) planning costs;
- (xii) survey of sites; and

any expression to which a meaning has been assigned in the Residential Area Regulations shall bear the meaning so assigned thereto.

#### MONEYS PAYABLE AND PAYMENT THEREOF

2. The rents, charges and other moneys payable by a person resident in a Black residential area within the administration area of the Administration Board shall be set out in Annexures A to V of the Schedule, and shall be paid at the office of the Superintendent of the Black residential area wherein such person resides.

#### RENT IN RESPECT OF SITES AND DWELLINGS AND ACCOMMODATION FEES IN RESPECT OF BLACK HOSTELS

3. The moneys determined hereunder shall be payable in respect of every month or part thereof—

- (a) for the letting of a site in respect of which a site permit has been issued in terms of the provisions of regulation 6 of Chapter 2 of the Residential Area Regulations;
- (b) for the letting of a site in respect of which a certificate of occupation has been issued in terms of the provisions of regulation 8 of Chapter 2 of the Residential Area Regulations;
- (c) for the letting of a dwelling in terms of the provisions of regulation 7 of Chapter 2 of the Residential Area Regulations; and
- (d) for accommodation in a Black hostel in terms of the provisions of regulation 13 of Chapter 7 of the Residential Area Regulations.

#### RENT IN RESPECT OF TRADING SITES

4. The rent determined hereunder in respect of trading sites shall be payable by every trader in respect of every month or part thereof.

#### MONEYS PAYABLE IN RESPECT OF EACH MONTH OR MONTHLY

5. Moneys in respect of sewerage, night soil removal, refuse removal, accommodation permits, water and the levy payable for the supply of electricity shall be payable for each month or part thereof, and the moneys payable per unit of electricity used shall be payable monthly.
