**1.** Artikel 124 van die Private Wet op die Randwaterraadstatute, 1950, word hierby gewysig deur in subartikel (1) die woorde „seshonderd-en-veertien” deur die woorde „negehonderd-en-twintig” te vervang. 5

**2.** Hierdie Wet heet die Wysigingswet op die Private Wet op die Randwaterraadstatute, 1982.

RAND WATER BOARD STATUTES (PRIVATE) ACT  
AMENDMENT ACT, 1982

Act No. 8, 1982

# ACT

To amend the Rand Water Board Statutes (Private) Act, 1950,  
with respect to the quantity of water which the Rand Water  
Board may abstract from a certain barrage in terms of the  
said Act.

(Afrikaans text signed by the State President.)  
(Assented to 16 February 1982.)

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 124 of the Rand Water Board Statutes (Private) Act, 1950, is hereby amended by the substitution in subsection 5 (1) for the words "six hundred and fourteen" of the words "nine hundred and twenty".  
Amendment of section 124 of Act 17 of 1950, as substituted by section 26 of Act 31 of 1972.
2. This Act shall be called the Rand Water Board Statutes Short title.  
(Private) Act Amendment Act, 1982.
