**Tot wysiging van die Elektrisiteitswet, 1958, om die Elektrisiteitsvoorsieningskommissie te magtig om die produksie of verskaffing van steenkool of ander brandstof, of die opgaar of verskaffing van water, wat hy vir of in verband met die ontwikkeling van elektrisiteit gebruik, te finansier; en om vir bykomstige aangeleenthede voorsiening te maak.**

**DAAR WORD BEPAAL** deur die Staatspresident en die Volksraad van die Republiek van Suid-Afrika, soos volg—

Wysiging van artikel 4 van Wet 40 van 1958, soos gewysig deur artikel 1 van Wet 33 van 1963 en artikel 1 van Wet 49 van 1971.

**1.** Artikel 4 van die Elektrisiteitswet, 1958, word hierby gewysig deur die volgende paragraaf by subartikel (1) te voeg:  
„(v) om, met die goedkeuring van die Minister en die Minister van Finansies en op 'n wyse wat die Minister bepaal, die produksie of verskaffing van steenkool of ander brandstof, of die opgaar of verskaffing van water, wat deur die kommissie vir of in verband met die ontwikkeling van elektrisiteit gebruik word, te finansier teen die sekuriteit wat die kommissie genoegsaam ag.”

Wysiging van artikel 10 van Wet 40 van 1958, soos gewysig deur artikel 4 van Wet 21 van 1980.

**2.** Artikel 10 van die Elektrisiteitswet, 1958, word hierby gewysig deur die volgende paragraaf by subartikel (1) te voeg:  
„(f) die finansiering van die produksie of verskaffing van steenkool of ander brandstof of van die opgaar of verskaffing van water kragtens artikel 4 (1) (v).”

## ELECTRICITY AMENDMENT ACT, 1982

Act No. 58, 1982

**ACT**

**To amend the Electricity Act, 1958, so as to authorize the Electricity Supply Commission to finance the production or supply of coal or other fuel, or the storage or supply of water, used by it for or in connection with the generation of electricity; and to provide for incidental matters.**

*(Afrikaans text signed by the State President.)  
(Assented to 26 March 1982.)*

**BE IT ENACTED** by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 4 of the Electricity Act, 1958, is hereby amended by the addition to subsection (1) of the following paragraph:  
5       "(v) with the approval of the Minister and the Minister of Finance and in such manner as may be determined by the Minister, to finance, against such security as the commission may deem sufficient, the production or supply of coal or other fuel, or the storage or supply of water, which is used by the commission for or in connection with the generation of electricity."  
10      Amendment of section 4 of Act 40 of 1958, as amended by section 1 of Act 33 of 1963 and section 1 of Act 49 of 1971.
2. Section 10 of the Electricity Act, 1958, is hereby amended by the addition to subsection (1) of the following paragraph:  
15       "(f) the financing of the production or supply of coal or other fuel or of the storage or supply of water under section 4 (1) (v)."  
15      Amendment of section 10 of Act 40 of 1958, as amended by section 4 of Act 21 of 1980.
3. This Act shall be called the Electricity Amendment Act, Short title.
