**WET**

Tot wysiging van die Wet op Padvervoer, 1977, ten einde die uitdrukking „gedesentraliseerde nywerheid” nader te omskryf; met betrekking tot die vervoer deur 'n gesentraliseerde nywerheid van sy eie goedere; en om voorsiening te maak vir die uitvaardiging van regulasies aangaande die vervoer van vrygestelde goedere; en vir aangeleenthede wat daarmee in verband staan.

(Goedgekeur op 1 Junie 1982.)

**DAAR WORD BEPAAL** deur die Staatspresident en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 1 van Wet 74 van 1977, soos gewysig deur artikel 1 van Wet 93 van 1979, artikel 1 van Wet 91 van 1980 en artikel 1 van Wet 64 van 1981.

- 1. Artikel 1 van die Wet op Padvervoer, 1977, word hierby gewysig—**
- (a) deur in subartikel (1) paragraaf (a) van die omskrywing van „gedesentraliseerde nywerheid” deur die volgende paragraaf te vervang:  
,(a) desentralisasievoordele of -hulp ontvang of ontvang het van die Departement van Nywerhedsweise, Handel en Toerisme en wat geleë is binne 'n gebied wat kragtens artikel 2 (c) tot 'n gesentraliseerde nywerheidsgebied verklaar is en wat voor sodanige verklaring [—  
(i) elders geleë was en daarheen verskuif is; of  
(ii) in daardie gebied gevestig is [ingevolge 'n skeema vir die uitbreiding van 'n onderneming wat nie in daardie gebied geleë is nie]; of";
- (b) deur paragraaf (v) van subartikel (2) deur die volgende paragraaf te vervang:  
,(v) die vervoer op die by regulasie voorgeskrewe wyse en voorwaardes deur 'n gesentraliseerde nywerheid van sy eie goedere in die loop van sy besigheid deur middel van slegs een vragvoertuig (uitechterd 'n sleepwa) [die draagvermoë waarvan nie agtduisend] waarvan die bruto-voertuigmassa nie ses-en-twintigduisend kilogram oorskry nie of deur middel van slegs een sleepwa waarvan die bruto-voertuigmassa nie agtduisend eenhonderd kilogram oorskry nie en waarvan die gesentraliseerde nywerheid die eienaar is, mits sodanige vragvoertuig of sleepwa, na gelang van die geval, op die by regulasie voorgeskrewe wyse geregistreer en geïdentifiseer is;";

## ACT

**To amend the Road Transportation Act, 1977, so as to further define the expression "decentralized industry"; with regard to the conveyance by a decentralized industry of its own goods; and to provide for the making of regulations concerning the conveyance of exempted goods; and for matters connected therewith.**

(Afrikaans text signed by the State President.)  
(Assented to 1 June 1982.)

**B**E IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 1 of the Road Transportation Act, 1977, is hereby amended—

5       (a) by the substitution in subsection (1) for paragraph (a) of the definition of "decentralized industry" of the following paragraph:

10      “(a) receives or has received decentralization benefits or assistance from the Department of Industries, Commerce and Tourism and which is situated within an area declared to be a decentralized industrial area under section 2 (c) and which prior to such declaration [—

15      (i) was situated elsewhere and had been transferred thereto; or

20      (ii) was established in that area [under any scheme of expansion of an undertaking which is not situated in that area]; or”;

25      (b) by the substitution for paragraph (v) of subsection (2) of the following paragraph:

30      “(v) the conveyance in the manner and on the conditions prescribed by regulation by a decentralized industry in the course of its business of its own goods by means of one goods vehicle only (except a trailer) the [carrying capacity] gross vehicle mass of which does not exceed [eight] twenty-six thousand kilograms or by means of one trailer only the gross vehicle mass of which does not exceed eighteen thousand one hundred kilograms and of which the decentralized industry is the owner, provided such goods vehicle or trailer, as the case may be, is registered and identified in the manner prescribed by regulation;”;

35      (c) by the substitution in paragraph (z) of subsection (2) for the words preceding subparagraph (i) of the following words:
