REPUBLIC OF SOUTH AFRICA CONSTITUTION ACT, 1961 (ACT 32 OF 1961)

ASSIGNMENT OF ADMINISTRATION OF CERTAIN LAWS TO THE MINISTER OF ENVIRONMENT AFFAIRS AND FISHERIES AND REDESIGNATION OF A DEPARTMENT OF STATE

It is hereby notified that the State President has been pleased—

- (a) under section 20A (1) of the Republic of South Africa Constitution Act, 1961, to assign the powers, duties and functions entrusted to the Minister of

Nywerheidswese, Handel en Toerisme, toegewys is met betrekking tot die uitvoering van ondergenoemde wette (en enige ander wette en wetsvoorskrifte wat verband hou met sy verantwoordelikheid vir die administrasie van die seevisserye-funksie), met ingang van 2 Augustus 1982 aan die Minister van Omgewingsake en Visserye op te dra, en met ingang van daardie datum die opdrag in dié verband aan die Minister van Landbou en Visserye, soos in paragraaf 2 (d) van Goewermentskennigewwing 349 van 18 Februarie 1980 bekendgemaak in te trek:

Wet op die Beskerming van Seevoëls en Robbe, 1973 (Wet 46 van 1973);

Wet op Seevisserye, 1973 (Wet 58 van 1973);

Wet op Territoriale Waters, 1963 (Wet 87 van 1963); en

Visnywerheid-ontwikkelingswet, 1978 (Wet 86 van 1978);

(b) kragtens artikel 20 (1) van die Grondwet van die Republiek van Suid-Afrika, 1961, die benaming van die Departement van Landbou en Visserye met ingang van 2 Augustus 1982 te verander na "Departement van Landbou".

Die benaming "Departement van Omgewingsake" bly onveranderd.

Industries, Commerce and Tourism, in relation to the administration of the undermentioned laws (and any other laws and legal prescripts relating to his responsibility for the administration of the sea-fisheries function), to the Minister of Environment Affairs and Fisheries with effect from 2 August 1982, and to withdraw with effect from that date the assignment in that connection to the Minister of Agriculture and Fisheries, as notified in paragraph 2 (d) of Government Notice 349 of 18 February 1980:

Sea Birds and Seals Protection Act, 1973 (Act 46 of 1973);

Sea Fisheries Act, 1973 (Act 58 of 1973);
Territorial Waters Act, 1963 (Act 87 of 1963); and
Fishing Industry Development Act, 1978 (Act 86 of 1978);

(b) under section 20 (1) of the Republic of South Africa Constitution Act, 1961, to change the designation of the Department of Agriculture and Fisheries to "Department of Agriculture" with effect from 2 August 1982.

The designation "Department of Environment Affairs" remains unchanged.
