*Toepassing in Suidwes-Afrika van Wet 50 van 1978, soos gewysig deur artikel 2 van Wet 71 van 1981*

1. Die Wet op Verpleging, 1978 [behalwe artikels 38 en 46 (5) en die woorde "en tree in werking op 'n datum wat die Staatspresident by proklamasie in die *Staatskoerant* bepaal" in artikel 47 (1), en artikel 47 (2) daarvan], soos deur artikel 2 van die Wysigingswet op Verpleging, 1981, gewysig, is ook in die gebied Suidwes-Afrika, met inbegrip van die Oostelike Caprivi Zipfel, van toepassing en word geag, behalwe met betrekking tot artikel 38A, op 28 Julie 1978 en, met betrekking tot genoemde artikel 38A, op 23 September 1981 vir bedoelde gebied in werking te getree het, en 'n verwysing daarin na die Republiek van Suid-Afrika word, tensy dit uit die samehang anders blyk, geag 'n verwysing ook na die gebied Suidwes-Afrika te wees.

**PROCLAMATION**

*by the State President of the Republic of South Africa*

No. 163, 1982

AMENDMENT OF THE NURSING ACT, 1978 (ACT 50 OF 1978), SO AS TO APPLY THE SAID ACT IN SOUTH WEST AFRICA

Under the powers vested in me by section 38 of the South West Africa Constitution Act, 1968 (Act 39 of 1968), I hereby make the laws set out in the Schedule.

**SCHEDULE**

*Application in South West Africa of Act 50 of 1978, as amended by section 2 of Act 71 of 1981*

1. The Nursing Act, 1978 [except sections 38 and 46 (5) and the words "and shall come into operation on a date to be fixed by the State President by proclamation in the *Gazette*" in section 47 (1), and section 47 (2) thereof], as amended by section 2 of the Nursing Amendment Act, 1981, shall apply also in the Territory of South West Africa, including the Eastern Caprivi Zipfel, and shall be deemed to have come into operation for the said territory, except in relation to the said section 38A, on 28 July 1978 and, in relation to the said section 38A, on 23 September 1981, and any reference therein to the Republic of South Africa shall, unless the context indicates otherwise, be deemed to include a reference to the Territory of South West Africa.

2. This Proclamation shall be called the Nursing Proclamation, 1982.

PROVINCIAL COUNCIL BY-ELECTION.—ELECTORAL DIVISION OF BOTHAVILLE

I, Marais Viljoen, State President of the Republic of South Africa—

(1) hereby determine, in terms of the provisions of sections 34 and 110 of the Electoral Act, 1979 (Act 45 of 1979)—

(a) that Tuesday, 28 September 1982, shall be the day on which a nomination court will sit in respect of the Electoral Division of Bothaville to receive nominations of candidates for election as a member of the Provincial Council of the Province of the Orange Free State for that electoral division;

(b) that the said nomination court shall sit in the Civil Court, Magistrate's Office, Parys, at 10h00;

(c) that if a poll becomes necessary in the said electoral division for the reason that more than one person shall have been duly nominated at the close of the sitting of the nomination court, the poll shall be taken on Wednesday, 3 November 1982, and shall commence at 07h00 on the said day and shall close at 21h00 on that day; and

(2) hereby appoint, in terms of the said provisions, Mr P. A. Mans, Magistrate, Magistrate's Office, Parys, as returning officer at the election in the aforesaid electoral division.
