**NOTICE IN TERMS OF SECTION 9A OF THE  
WATER ACT, 1956**

**PROHIBITION ON THE FURTHER STORAGE IN AND CURTAILMENT OF THE ABSTRACTION FOR IRRIGATION PURPOSES OF PUBLIC WATER FROM THE CROCODILE RIVER IN THE CROCODILE (EASTERN TRANSVAAL) GOVERNMENT WATER CONTROL AREA AND A CERTAIN PORTION OF THE ELANDS RIVER**

By virtue of the powers vested in me by section 9A of the Water Act, 1956 (Act 54 of 1956), I, Sarel Antoine Strydom Hayward, in my capacity as Minister of Environment Affairs and Fisheries do hereby declare—

(1) that in my opinion a severe water-shortage exists in respect of the Crocodile River in the Crocodile River (Eastern Transvaal) Government Water Control Area and in that portion of the Elands River from and including the farm Doornhoek 341 JT to the confluence of the said river with the Crocodile River; and

(2) I hereby prohibit any further storage by private individuals of any water in the bed of the Crocodile River in the said Government Water Control Area and in the bed of the portion concerned of the Elands River; and

(3) I hereby impose the measures set out in the Schedule hereto which, except where otherwise provided for in the Schedule, are aimed at a curtailment of approximately 50 per cent in the quantity of water which may be abstracted for irrigation purposes from the said rivers in accordance with the provisions of section 9 of the said Act, or, as the case may be, on the authority of permits issued in terms of section 62 of the Act, excluding flood-water permits or the abstraction of surplus water in terms of section 10 of the Act, in respect of which an absolute prohibition is hereby imposed; and

(4) I determine as follows the manner in which such curtailment shall be effected:

(a) For the purposes of this notice, the Crocodile River (Eastern Transvaal) Government Water Control Area as well as land riparian to the portion of the Elands River

**VERBOD OP DIE VERDERE OPGARING IN EN INKORTING VAN DIE UITNEEM VIR BESPROEINGSDOELEINDES VAN OPENBARE WATER UIT DIE KROKODILRIVIER BINNE DIE KROKODILRIVIER (OOS - TRANSVAAL) - STAATSWATERBEHEERGEBIED EN 'N SEKERE GEDEELTE VAN DIE ELANDSRIVIER**

Kragtens die bevoegdheid my verleen by artikel 9A van die Waterwet, 1956 (Wet 54 van 1956), verklaar ek, Sarel Antoine Strydom Hayward, in my hoedanigheid van Minister van Omgewingsake en Visserye—

(1) dat daar na my oordeel 'n waternood bestaan ten opsigte van die Krokodilrivier binne die Krokodilrivier (Oos-Transvaal)-staatswaterbeheergebied en die gedeelte van die Elandsrivier vanaf en met insluiting van die plaas Doornhoek 341 JT tot die samevloeiing van die genoemde rivier met die Krokodilrivier; en

(2) verbied ek hierby die verdere opgaring deur private individue van enige water in die bedding van die Krokodilrivier binne die genoemde Staatswaterbeheergebied en in die bedding van die betrokke gedeelte van die Elandsrivier; en

(3) stel ek hierby die maatreëls uiteengesit in die Bylae hiertoe in, wat behalwe waar anders in die Bylae bepaal word, ten doel het 'n inkorting van ongeveer 50 persent op die hoeveelheid openbare water wat vir besproeiingsdoeleindes uit die genoemde riviere uitgeneem mag word ooreenkomstig die bepalings van artikel 9 van die Wet of, na gelang van die geval, op gesag van permitte uitgereik kragtens artikel 62 van die Wet, uitgesonder vloedwaterpermitte of die uitneem van surpluswater kragtens artikel 10 van die Wet, ten opsigte waarvan 'n absolute verbod hierby ingestel word; en

(4) bepaal ek soos volg die wyse waarop sodanige inkorting bewerkstellig moet word:

(a) Vir die doeleindes van hierdie kennisgewing word die Krokodilrivier (Oos-Transvaal)-staatswaterbeheergebied asook oewergrond ten opsigte van die betrokke

concerned, are divided into zones as set out in the Schedule hereto, and the measures set out in respect of each zone, shall apply;

(b) I hereby delegate in terms of section 165 of the said Act to the Circle Engineer (Eastern Transvaal) the power—

(i) to amend in his discretion by notice in the *Gazette*, the provisions of the Schedule to this notice in general or in respect of any particular user concerned in order to attain with due regard to local conditions, the required curtailment;

(ii) with due regard to a deterioration or improvement in the availability of water in the rivers concerned, by notice in the *Gazette*—

(aa) to extend or relax the envisaged curtailment referred to in paragraph (3) or, as the case may be, to raise it indefinitely in which case this notice shall be deemed to have been revoked by me;

(bb) to temporarily raise the prohibition referred to in paragraph (2) on the further storage of water; and

(cc) to temporarily take over the operation of any private water work by means of which water to which this notice applies, is abstracted, impounded, stored, supplied or used for irrigation purposes and to cause the operation of such water work to be undertaken in accordance with his directions by any person directed in writing thereto by the said Circle Engineer.

General Notice 684 of 7 September 1979 is hereby repealed.

8.2 *Operation of certain water works.*—The operation of the following private water works is hereby vested in the Circle Engineer (Eastern Transvaal) and shall be undertaken in accordance with his directives by any person instructed thereto in writing by him:

(a) The storage-dam in the Crocodile River on the Remaining Extent of Thankerton 175 JU as well as the appurtenant canal: Provided that—

(i) the Circle Engineer (Eastern Transvaal) shall make an estimate of the quantity of water which the owner concerned has lawfully stored in the said storage-dam on the date of this notice;

(ii) the Circle Engineer (Eastern Transvaal) shall ensure that subject to subparagraph (iii), the quantity of water referred to in subparagraph (i) will at all times remain available to the owner concerned in the storage-dam concerned; and

(iii) the owner of the storage-dam concerned may at any time with the approval of the Circle Engineer (Eastern Transvaal), abstract from the storage-dam the quantity of water referred to in subparagraph (i) or any portion thereof, provided that the Circle Engineer (Eastern Transvaal) is satisfied that such abstraction will not detrimentally affect the availability of any water in the river for lower riparian owners.

(b) The weir in the Crocodile River on Portion 6 of Thankerton 175 JU with the appurtenant canal. Water shall only be diverted into the canal concerned during the pumping turn of the owner concerned as set out in paragraph 8.1.
