Greetings!

Whereas I, as it appears from *Government Gazette* 8473 of 10 December 1982, have deemed it expedient to appoint a commission to investigate, report on and make recommendations in regard to the matters mentioned hereinafter;

And by reason of the great trust I repose in your knowledge, judgment and ability, I hereby authorise and appoint you to be a member of the Commission, in the place of Dr Cyril Lincoln Sbusiso Nyembezi, who with my approval, withdraw as a member of the Commission, with the following terms of reference:

To investigate, and report on and make recommendations in regard to the conflicting claims between the Kingdom of Swaziland and KwaZulu over the district of Ingwavuma and taking into consideration the interests of the inhabitants of the Ingwavuma area, consider the desirability or otherwise to make border adjustments between South Africa and Swaziland.

Given under my Hand and the Seal of the Republic of South Africa at Durban this Twenty-first day of December, One thousand Nine hundred and Eighty-two.
