**BYLAE**

1. Wysig item 1 (a) van Afdeling VIII om soos volg te lui:

“1. Die bevordering van—

(a) beampies/kontrakwerkneemers wat poste in die Administratiewe, Vakkundige, Klerklike, Tegniese en Algemene A-afdelings beklee (uitgesonderd beampies/kontrakwerkneemers in daardie beroepsklasse wat deur die Kommissie geïdentifiseer is/word) wie se beurt op bevordering aangebreek het, tot bestaande *vakante poste*, maar beperk tot poste waarvan die maksima van die standaard-salarisskale *laer* is as dié verbonde aan die volgende range:”.

2. Skrap die woorde “in die Vakkundige Afdeling” by item 1 (f) van Afdeling VIII..

3. Wysig item 6 (a) van Afdeling VIII om soos volg te lui:

“6. Die verandering van—

(a) benamings/subbenamings en oorplasings van beampies (uitgesonderd beampies in daardie beroepsklasse wat deur die Kommissie geïdentifiseer is/word) van een afdeling van die Staatsdiens na 'n ander of binne diëselfde afdeling van die Staatsdiens, beperk ten opsigte van oorplasings, tot die range waartoe bevorderings ingevolge hierdie aanhangsel bewerkstellig kan word; en”.

ASSIGNMENT OF MATTERS INVOLVING THE PUBLIC SERVICE TO MINISTERS AND ADMINISTRATORS

By virtue of the powers vested in me by section 5A (2) of the Public Service Act, 1957 (Act 54 of 1957), as amended, I hereby amend Part A of the Annex to Proclamation 88 of 1983, as published in *Government Gazette* 8745 of 1 June 1983, to the extent indicated in the Annex hereto.

Given under my Hand and the Seal of the Republic of South Africa at Pretoria this Sixteenth day of November, One thousand Nine hundred and Eighty-three.

**ANNEX**

1. Amend item 1 (a) of Section VIII to read as follows:

“1. The promotion of—

(a) officers/contract employees holding posts in the Administrative, Professional, Clerical, Technical and General A Divisions (other than officers/contract employees in those occupational classes which have been/are identified by the Commission) whose turn it is for promotion, to existing *vacant posts*, but restricted to posts the maxima of the standard salary scales of which are *lower* than those attached to the following ranks:”.

2. Delete the words “in the Professional Division” at item 1 (f) of Section VIII.

3. Amend item 6 (a) of Section VIII to read as follows:

“6. The changing of—

(a) designations/subdesignations and the transfer of officers (other than officers in those occupational classes which have been/are identified by the Commission) from one division of the Public Service to another or within the same division of the Public Service, restricted, in respect of transfers, to the ranks to which officers can be promoted in terms of this Annex; and”.

4. Wysig item 9 (a) van Afdeling VIII om soos volg te lui:

“9. Indienshouding buite verband—

(a) teen hoër of gelykgegradeerde poste van beamptes/werknemers in alle departemente, met die uitsondering van beamptes in daardie beroepsklasse wat deur die Kommissie geïdentifiseer is/word, beperk tot range waarvan die maksima van die standaardsalarisskale laer is as dié verbonde aan die rang van Adjunk-direkteur: Administrasie en verder beperk tot poste binne die betrokkenes se werksefer (beamptes/werknemers mag met ander woorde slegs teen poste in *verwante* werkligtings in diens gehou word);”.

5. Wysig item 10 van Afdeling VIII om soos volg te lui:

“10. Die gepaste opname van alle beamptes wat buite verband of bykomend tot die vaste diensstaat in diens gehou was, uitgesonderd beamptes in daardie beroepsklasse wat deur die Kommissie geïdentifiseer is/word.”.

4. Amend item 9 (a) of Section VIII to read as follows:

“9. The employment out of adjustment of—

(a) officers/employees in all departments (other than officers in those occupational classes which have been/are identified by the Commission) against higher or equally graded posts, restricted to ranks the maxima of the standard salary scales of which are lower than that of the rank of Deputy Director: Administration and restricted further to posts within the work sphere of the persons concerned (in other words, officers/employees may only be employed against posts in *related* occupational fields);”.

5. Amend item 10 of Section VIII to read as follows:

“10. The absorption in appropriate posts of all officers employed out of adjustment or additional to the fixed establishment, other than officers in those occupational classes which have been/are identified by the Commission.”.

3. This arrangement is to bring the *Government Gazettes* in conformity with Gazettes containing Acts of Parliament etc. where the language sequence remains constant throughout the sitting of Parliament.
4. It is therefore expected of you, the advertiser, to see that your copy is in accordance with the above-mentioned arrangement in order to avoid unnecessary style changes and editing to correspond with the correct style.
