**GATHERINGS PROHIBITED UNDER SECTION 46 (3)
OF THE INTERNAL SECURITY ACT, 1982**

1. Whereas I, Louis le Grange, Minister of Law and Order, deem it expedient for the maintenance of the public peace, I hereby prohibit, under section 46 (3) of the Internal Security Act, 1982 (Act 74 of 1982)—

(a) any gathering, except any bona fide sport occasion, which, with a view of its holding outside a building, is organised or convened for any date during the period 22 March 1985 up to and including 31 March 1986 at any place in the Republic, or which is held on any such date at any such place outside a building; or

(b) any gathering which, with a view of its holding within any building, is organised or convened for any date during the period mentioned in paragraph (a) at any

**BYEENKOMSTE VERBIED KRAGTENS ARTIKEL 46

(b) enige byeenkoms wat vir enige datum gedurende die tydperk in paragraaf (a) vermeld op enige plek in die Republiek met die oog op die hou daarvan binne 'n gebou, gereël of belê word, of wat op enige sodanige datum

place in the Republic, or which is held on any such date at any such place within a building to advise, encourage, propagate, advocate or promote the non-attendance or opposition to the attendance of any school, college, university or other educational institution by any person,

unless such gathering is authorised by me or, subject to the provisions of the said section 46 (3), by a magistrate of the district in which the gathering is contemplated.

2. Government Notice 579 of 30 March 1984 is hereby withdrawn.
