Act No. 88, 1985

SECOND FINANCE ACT, 1985

ACT

To provide for the disposal of certain surplus State revenue; and for a payment from the State Revenue Account to the Tax Reserve Account; to authorize the Minister of Finance to enter into a certain agreement; to amend the South African Mint and Coinage Act, 1964, so as to replace the First Schedule; and to provide for matters connected therewith.

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Disposal of
certain surplus
State revenue.

1. From the surplus in the State Revenue Account as at 31 March 1985, as certified by the Auditor-General, there shall be paid to the Gold and Foreign Exchange Contingency Reserve Account established under section 17D of the South African Reserve Bank Act, 1944 (Act No. 29 of 1944), an amount of not more than R654 651 063,52 in settlement of the deficit in the latter account as at 31 March 1984. 5

2. From the State Revenue Account there shall be paid during 10 the 1985-'86 financial year to the Tax Reserve Account established under section 1 of the Tax Reserve Account Act, 1964 (Act No. 82 of 1964), an amount of R250 000 000.

3. (1) The Minister of Finance may enter into an agreement with O'okiep Copper Company, Limited (hereinafter referred to as the company), Barclays National Bank, Limited, Barclays Industrial Bank, Limited, Gold Fields of South Africa, Limited, and Newmont Mining Corporation whereby the agreement contemplated in section 2 of the Finance Act, 1982 (Act No. 96 of 1982) (hereinafter referred to as the 1982 agreement), is cancelled as a result of the failure of the company to meet its obligations in terms of the 1982 agreement, and whereby the Government will become entitled to take securities by virtue of the payment by the Government to Barclays National Bank, Limited, of an amount of R32 770 306,17, determined in terms of the 1982 agreement, and whereby the company undertakes to repay that amount in terms of the agreement contemplated in this section, and whereby other matters relating to the failure of the company to meet its obligations in terms of the 1982 agreement are arranged. 20 25 30

(2) Subsection (1) shall be deemed to have come into operation on 21 September 1984.

4. The following Schedule is hereby substituted for the First Schedule to the South African Mint and Coinage Act, 1964:

WET

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

1. Uit die surplus in die Staatsinkomsterekening soos op 31 Maart 1985, soos deur die Ouditeur-generaal gesertifiseer, word daar aan die goud-en-buitelandsevaluta-gebeurlikheidsreserwerekening ingestel kragtens artikel 17D van die Wet op die Suid-Afrikaanse Reserwebank, 1944 (Wet No. 29 van 1944), 'n bedrag van hoogstens R654 651 063,52 oorbetalings ter vereffening van die tekort in laasgenoemde rekening soos op 31 Maart 1984. Besteding van sekere surplusstaatsinkomste.
10. 2. Uit die Staatsinkomsterekening word daar gedurende die boekjaar 1985-'86 aan die Belastingreserwerekening, ingestel kragtens artikel 1 van die Wet op die Belastingreserwerekening, 1964 (Wet No. 82 van 1964), 'n bedrag van R250 000 000 oorbetalings. Oorbetalings uit Staatsinkomsterekening aan Belastingreserwerekening.
15. 3. (1) Die Minister van Finansies kan met "O'okiep Copper Company, Limited" (hieronder die maatskappy genoem), Barclays Nasionale Bank, Beperk, Barclays Industriële Bank, Beperk, "Gold Fields of South Africa, Limited" en "Newmont Mining Corporation" 'n ooreenkoms aangaan waarby die ooreenkoms bedoel in artikel 2 van die Finansiewet, 1982 (Wet No. 96 van 1982) (hieronder die 1982-ooreenkoms genoem), gekanselleer word weens die nie-nakoming deur die maatskappy van sy verpligtinge ingevolge die 1982-ooreenkoms, en waarby die Regering geregtig word om sekuriteite te neem ten aansien van die betaling deur die Regering aan Barclays Nasionale Bank, Beperk, van 'n bedrag van R32 770 306,17, bepaal ingevolge die 1982-ooreenkoms, en waarby die maatskappy onderneem om daardie bedrag terug te betaal ingevolge die ooreenkoms bedoel in hierdie artikel, en waarby ander aangeleenthede gereël word wat voortspruit uit die nie-nakoming deur die maatskappy van sy verpligtinge ingevolge die 1982-ooreenkoms. Magtiging om sekere ooreenkoms aan te gaan.
20. (2) Subartikel (1) word geag op 21 September 1984 in werking te getree het.
25. 4. Die Eerste Bylae by die Wet op die Suid-Afrikaanse Munt en Munte, 1964, word hierby deur die volgende Bylae vervang: Vervanging van Eerste Bylae by Wet 78 van 1964, soos vervang deur artikel 16 van Wet 100 van 1980.
