Act No. 100, 1985

PENSIONS (SUPPLEMENTARY) ACT, 1985

ACT

To provide for the granting of certain pension benefits.

*(English text signed by the State President.)—
(Assented to 10 July 1985.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

Granting of certain
pension benefits.

1. Notwithstanding anything to the contrary in any law, the persons mentioned in the Schedule shall be entitled to the benefits contemplated therein.

Short title.

2. This Act shall be called the Pensions (Supplementary) Act, 1985.

Schedule

(1) There shall be paid to J T Durrant, formerly Chief of the Air Force, a pension of R6 000 per annum from the State Revenue Fund with effect from 1 October 1985.

(2) The pension awarded to Jacomina H de Villiers in terms of item 7 of the Schedule to the Pensions (Supplementary) Act, 1969 (Act No. 100 of 1969), shall be increased to R4 800 per annum with effect from 1 October 1985.

(1) Daar word aan J T Durrant, voorheen Hoof van die Lugmag, met ingang van 1 Oktober 1985 'n pensioen van R6 000 per jaar uit die Staatsinkomstefonds betaal.

(2) Die pensioen wat ingevolge item 7 van die Bylae by die Wet tot Aanvulling van Pensioene, 1969 (Wet No. 100 van 1969), aan Jacomina H de Villiers toegeken is, word met ingang van 1 Oktober 1985 tot R4 800 per jaar verhoog.
