#### DIRECTIONS FOR THE MANAGEMENT AND DEVELOPMENT OF LAND SITUATED WITHIN THE CAPE PENINSULA NATURE AREA

Under and by virtue of the powers vested in me by section 10 (1) of the Environment Conservation Act, 1982 (Act 100 of 1982), I hereby issue the directions contained in the Schedule hereto in respect of the management and development of land situated within the Cape Peninsula Nature Area reserved by Government Notice 171 of 10 February 1984.

#### SCHEDULE

#### ERADICATION AND CONTROL OF UNDESIRABLE PLANT SPECIES

Measures should be taken to eradicate the following plant species and to combat their spreading in the area:

*Acacia cyclops,*  
*Acacia saligna,*  
*Acacia longifolia,*  
*Hakea spp.*

and any other exotic plant species which has proliferated in the area to such an extent as to threaten the survival of the indigenous plant species in the area.

#### COMBATING OF SOIL EROSION

Measures should be taken to combat soil erosion in the area.
