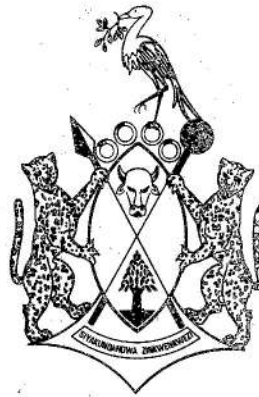

ACT No. 29 OF 1985**

SECOND LIQUOR AMENDMENT ACT, 1985

ACT

To amend the Liquor Act, 1983.

(English text signed by the President. Assented to on 12 December 1985)

BE IT ENACTED by the National Assembly of the Republic of the Republic of Ciskei, as follows:—

Amendment of section 1 of Act 13 of 1983, as amended by section 1 of Act 23 of 1984 and section 1 of Act 3 of 1985.

1. Section 1 of the Liquor Act, 1983 (hereinafter in this Act referred to as the principal Act) is hereby amended —
 - (a) by the insertion after the definition of "condition" of the following definition:
" 'corporation' means a corporation established under section 5 (1) of the Ciskeian Corporations Act, 1981 (Act 16 of 1981);";
 - (b) by the substitution for the definition of "chief" of the following definition:
" 'chief' means a chief as defined in section 1 of the Administrative Authorities Act, 1984 (Act 37 of 1984);
 - (c) by the substitution for the definition of "headman" of the following definition:
" 'headman' means a headman as defined in section 1 of the Administrative Authorities Act, 1984;";
 - (d) by the substitution for the definition of "regional authority" of the following definition:
" 'regional authority' means a regional authority established or deemed to have been established by section 8 of the Administrative Authorities Act, 1984;";
 - (e) by the substitution for the definition of "tribal authority" of the following definition:
" 'tribal authority' means a tribal authority as defined in section 1 of the Administrative Authorities Act, 1984;".

Amendment of section 133 of Act 13 of 1983, as amended by section 8 of Act 22 of 1984 and section 5 of Act 23 of 1984.

2. Section 133 of the principal Act is hereby amended by the substitution for paragraph (f) of the following paragraph:
"(f) any person who, on behalf of any State department, a corporation, the Tourist Authority or any other corporate body established by or under any law, sells liquor in any national park or game or nature reserve under authority granted by the Minister and on conditions, or subject to such restrictions, as the Minister may determine."

Short title.

3. This Act shall be called the Second Liquor Amendment Act, 1985.
