On 1985-12-20 the Directorate of Publications appealed under section 14 of the Publications Act, 1974 (the Act), against the decision on 1985-12-19 of a Committee referred to in section 4 of the Act, that the undermentioned publications are not undesirable within the meaning of section 47 (2) of the Act.

The Directorate appeals for the imposing of conditions by the Appeal Board.

The publications Appeal Board has provisionally decided under section 14 (4) (b) (i) (aa) of the Act that the undermentioned publications are not undesirable within the meaning of section 47 (2) of the said Act, subject to the condition that the publications may not be displayed in public for purposes of distribution.

The period within which persons referred to in section 14 (3) (b) of the Act may make representations to the Publications Appeal Board, Private Bag X114, Pretoria; in respect of the said publications are hereby determined as 10 days from the date of this notice.

If no representations are received the Appeal Board's decision will be final.
