DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Bewilliging van addisionele bedrae geld vir behoeftes van Staat.

1. Behoudens die bepalings van die Skatkis- en Ouditwet, 1975 (Wet No. 66 van 1975), word daar hierby vir die behoeftes van die Staat in die boekjaar wat op 31 Maart 1986 eindig, as 'n las teen die Staatsinkomsterekening, die addisionele bedrae geld uiteengesit in kolom 1 van die Bylae bewillig.

ADDITIONAL APPROPRIATION ACT, 1986

Act No. 17, 1986

ACT

To appropriate an additional amount of money for the requirements of the State during the financial year ending 31 March 1986.

*(Afrikaans text signed by the State President.)
(Assented to 10 March 1986.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the State during the financial year ending 31 March 1986, as a charge to the State Revenue Account, the additional amounts of money shown in column 1 of the Schedule.
2. This Act shall be called the Additional Appropriation Act, 1986.
