ACT

BE IT ENACTED by the State President and the House of Representatives of the Republic of South Africa, as follows:—

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1986, as a charge to the Appropriation Account: House of Representatives, the additional amounts of money shown in column 1 of the Schedule.
