Om die Wet op Nasionale Studielenings en -beurse, 1964, te herroep; en om voorsiening te maak vir die verdeling van die balans in die fonds ingestel by artikel 2 van daardie Wet.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Herroeping van
Wet 89 van 1964.

1. Die Wet op Nasionale Studielenings en -beurse, 1964, word hierby herroep.

Verdeling van
balans in fonds.

2. Enige balans in die fonds ingestel by artikel 2 van die Wet 5 op Nasionale Studielenings en -beurse, 1964 (Wet No. 89 van 1964), word so gou doenlik na die inwerkingtreding van hierdie Wet deur die Direkteur-generaal: Nasionale Opvoeding verdeel onder "universiteite", soos omskryf in artikel 1 van gemelde Wet, en "verklaarde instellings", soos in gemelde artikel om-10 skryf, op die grondslag wat die Minister van Nasionale Opvoeding met die instemming van die Minister van Finansies bepaal.

Kort titel.

3. Hierdie Wet heet die Wet op die Herroeping van die Wet op Nasionale Studielenings en -beurse, 1986.

NATIONAL STUDY LOANS AND BURSARIES ACT REPEAL ACT,
1986

Act No. 8, 1986

ACT

To repeal the National Study Loans and Bursaries Act, 1964; and to provide for the division of the balance in the fund established by section 2 of that Act.

*(English text signed by the State President.)
(Assented to 10 March 1986.)*

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

1. The National Study Loans and Bursaries Act, 1964, is hereby repealed. Repeal of
Act 89 of 1964.
- 5 2. Any balance in the fund established by section 2 of the National Study Loans and Bursaries Act, 1964 (Act No. 89 of 1964), shall as soon as possible after the commencement of this Act be divided by the Director-General: National Education among "universities", as defined in section 1 of the said Act, and "de-
10 clared institutions", as defined in the said section, on the basis determined by the Minister of National Education with the concurrence of the Minister of Finance. Division of

3. This Act shall be called the National Study Loans and Bursaries Act Repeal Act, 1986. Short title.
