Tot wysiging van die Nasionale Welsynswet, 1978 (in soverre dit as 'n Wet oor die eie sake van die Raad van Verteenwoordigers toegepas word), ten einde voorsiening te maak vir veranderings in die lidmaatskap van streekwelsynsrade.

DAAR WORD BEPAAL deur die Staatspresident en die Raad van Verteenwoordigers van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 7 van Wet 100 van 1978.

1. Artikel 7 van die Nasionale Welsynswet, 1978, word hierby gewysig deur subartikel (2) deur die volgende subartikel te vervang: 5

“(2) Die lede van 'n streekwelsynsraad word na goed-dunke deur die Minister aangestel, en [minstens drie-vierdes van dié lede] moet persone wees [wie se] wat in die betrokke streek woonagtig of werkzaam is, ongeag of hulle 10 name op die nominasielys [vir] ten opsigte van die [betrokke] streek voorkom of nie.”.

2. Hierdie Wet heet die Nasionale Welsynswysigingswet (Raad van Verteenwoordigers), 1986.

NATIONAL WELFARE AMENDMENT ACT (HOUSE OF REPRESENTATIVES), 1986

Act No. 18, 1986

ACT

To amend the National Welfare Act, 1978 (in so far as it is applied as an Act on the own affairs of the House of Representatives), so as to provide for changes in the membership of regional welfare boards.

(Assented to 10 March 1986.)

BE IT ENACTED by the State President and the House of Representatives of the Republic of South Africa, as follows:—

1. Section 7 of the National Welfare Act, 1978, is hereby amended by the substitution for subsection (2) of the following subsection:

10 “(2) The members of a regional welfare board shall be appointed by the Minister as he deems fit, and [at least three-fourths of such members] shall be persons [whose] who are resident or employed in the region concerned, irrespective of whether or not their names appear on the nomination list [for the] in respect of such region [concerned]. ”.

15 2. This Act shall be called the National Welfare Amendment Act (House of Representatives), 1986.
