NOTICE IN TERMS OF REGULATION 4 (3) OF THE EXCHANGE CONTROL REGULATIONS, 1961

Whereas the South African Reserve Bank has been authorised by the Minister of Finance to perform the powers and functions assigned to the Treasury in terms of Regulation 4 of the Exchange Control Regulations published under Government Notice R. 1111 of 1 December 1961, as amended;
