BYEENKOMSTE VERBIED KRAGTENS ARTIKEL 46 (3) VAN DIE WET OP BINNELANDSE VEILIGHEID, 1982

Aangesien ek, Louis le Grange, Minister van Wet en Orde, dit nodig ag vir die handhawing van die openbare rus, verbied ek hierby kragtens artikel 46 (3) (b) van die Wet op Binnelandse Veiligheid, 1982 (Wet 74 van 1982), enige byeenkoms in enige gebou waar ook al in die Republiek gedurende die tydperk 4 Junie 1986 tot en met 30 Junie 1986, indien daardie byeenkoms 'n byeenkoms is wat gereël, belê of gehou word of andersins teweeggebring word om—

- (a) enige toestand of voorval van openbare rusverstoring, wanordelikhede, oproer of openbare geweldpleging wat op 16 Junie 1976, of te eniger tyd daarna, te Soweto in die landdrosdistrik Johannesburg, of te enige ander plek in die Republiek geheers of plaasgevind het; of
- (b) die aanvaarding van die "Freedom Charter" op 26 Junie 1955 deur die sogenaamde "Congress of the People" te Kliptown in die voormelde distrik,

te herdenk, behalwe enige sodanige byeenkoms wat ek, of, behoudens die bepalings van artikel 46 (3) van genoemde Wet, die landdros van die distrik waar die byeenkoms gehou staan te word, te eniger tyd uitdruklik magtig.

GOVERNMENT NOTICE

MINISTRY OF LAW AND ORDER

GATHERINGS PROHIBITED UNDER SECTION 46 (3) OF THE INTERNAL SECURITY ACT, 1982

Whereas I, Louis le Grange, Minister of Law and Order, deem it necessary for the maintenance of the public peace, I hereby under section 46 (3) (b) of the Internal Security Act, 1982 (Act 74 of 1982), prohibit any gathering in any building wheresoever in the Republic during the period 4 June 1986 up to and including 30 June 1986, if such gathering is a gathering organised, convened or held or otherwise brought about to commemorate—

- (a) any state or incident of public disturbance, disorder, riot or public violence which prevailed or occurred on 16 June 1976, or at any time thereafter, at Soweto in the Magisterial District of Johannesburg, or at any other place in the Republic; or
- (b) the adoption of the Freedom Charter by the so-called Congress of the People at Kliptown in the said district on 26 June 1955,

except any such gathering expressly authorized by me, or, subject to the provisions of section 46 (3) of the said Act, by the magistrate of the district in which the gathering is to be held.
