ORDERS BY THE DIVISIONAL COMMISSIONER OF
THE SOUTH AFRICAN POLICE FOR THE EAST RAND
DIVISION

Under the powers vested in me by regulation 7 of the Regulations in terms of the Public Safety Act, 1953 (Act 3 of 1953), promulgated by Proclamation R. 109 of 12 June 1986, I, Frederik George van Zyl, Divisional Commissioner of the South African Police for the East Rand Division, hereby repeal the orders set out in Schedule B issued by Government Notice 1237 of 13 June 1986 and issue with reference to the areas set out in Schedule A in the Magisterial Districts of Alberton, Benoni, Kempton Park, Springs, Nigel, Balfour, Delmas, Heidelberg, Boksburg, Brakpan the orders set out in Schedule B in respect of funeral ceremonies, including any memorial service, commemorative service, funeral procession or burial, of any person who has apparently died as a result of unnatural causes.

Voorwaardes ten opsigte van sekere begrafnisse in die gebiede vermeld in Bylae A

 - (3) Slegs 'n geordende leraar van godsdiestige denominasie of organisasie mag as spreker tydens enige verrigtinge by so 'n begrafnisseremonie optree.
 - (4) Die begrafnisgangers wat sodanige begrafnis bywoon, moet per voertuig vanaf die plek waar die roudiens of gedenkdiens plaasgevind het na die plek waar die oorledene teraardebestel word, beweg en wel langs 'n roete wat die gemelde Afdelingskommissaris van die Suid-Afrikaanse Polisie bepaal.
 - (5) Geen vlae, baniere, plakkate, pamphlette of aanplakbiljette mag by of tydens sodanige begrafnisseremonie vertoon of versprei word nie.
 - (6) Geen luidsprekerstelsel mag by of tydens die begrafnisseremonie gebruik word nie.
 - (7) 'n Bepaalde begrafnisseremonie word nie met betrekking tot meer as een sodanige oorledene gehou nie en geen sodanige seremonie word bygewoon deur meer as 200 persone nie.
 - (8) 'n Bepaalde begrafnisseremonie van so 'n oorledene mag nie langer as vier uur duur nie.
2. Die gemelde Afdelingskommissaris van die Suid-Afrikaanse Polisie kan, op skriftelike aansoek en onderworpe aan die voowaardes, as daar is, wat hy goedvind, vrystelling van enige of al die bogemelde bevele verleen.

SCHEDULE B

Orders

Conditions in respect of certain funeral ceremonies in the areas mentioned in Schedule A

1. (1) No funeral ceremonies may take place during weekends or on public holidays.
 - (2) No memorial or commemorative service in connection with a funeral of a deceased person referred to above, shall be held out of doors.
 - (3) Only an ordained minister of a religious denomination or organization may act as a speaker during any proceedings at any such funeral ceremony.
 - (4) Persons concerned who are attending such funeral shall only travel by vehicle from the place where the memorial or commemorative service has taken place to the place where the deceased is to be buried, and along a route determined by the said Divisional Commissioner of the South African Police.
 - (5) No flags, banners, placards, pamphlets or posters shall be displayed or distributed at or during such funeral ceremony.
 - (6) No public address system shall be used at or during such funeral ceremony.
 - (7) A particular funeral ceremony shall not be held with regard to more than one such deceased person and no such ceremony shall be attended by more than 200 persons.
 - (8) A particular funeral ceremony shall not last for more than four hours.
2. The said Divisional Commissioner of the South African Police may, on written application and subject to such conditions, if any, as he may deem fit, grant exemption from any or all of the above-mentioned orders.

Beheer oor nie-inwoners van 'n gebied

Geen persoon wat nie in 'n gebied soos omskryf in Bylae A, woonagtig is nie of tot bevrediging van 'n lid van 'n Mag kan bewys dat hy aldus woonagtig is nie, mag so 'n gebied binnegaan of daarbinne bly nie sonder skriftelike toestemming van 'n lid van 'n Mag en onderworpe aan die voorwaardes wat so 'n lid noodsaklik of dienstig ag en in sodanige skriftelike toestemming bepaal.

Brandstofbeheer

2. (1) Niemand mag in die gebiede soos omskryf in Bylae A in besit wees van petrol in 'n houer van watter aard ook al nie, uitgesonderd die brandstoffenk van 'n motorvoertuig; en

(2) niemand mag petrol uit die brandstoffenk van 'n motorvoertuig in 'n houer van watter aard ook al uittap nie, behalwe met die skriftelike toestemming van 'n lid van 'n Mag.

SCHEDULE B

Orders

Control over non-residents of an area

1. No person who is not resident in an area as described in Schedule A, or who cannot prove to the satisfaction of a member of a Force that he is so resident, may enter or be in such area without the written permission of a member of a Force and subject to such conditions as such a member may deem necessary or expedient, as specified in such written permission.

Control over petrol

2. (1) No person shall in the areas as described in Schedule A be in possession of petrol in a container of whatever nature, excluding the petrol tank of a motor vehicle; and

(2) no such person shall siphon petrol from the petrol tank of a motor vehicle into a container of whatever nature, except with the written permission of a member of a Force.

Beheer oor skoolboikotte

3. (1) Geen ingeskreve leerling van enige skool in 'n gebied in Bylae A vermeld, mag op enige skooldag waarop hy hom op die skoolterrein van daardie skool bevind gedurende die ure waartydens normaalweg aan daardie skool onderrig verleen word, buite 'n klaskamer van die skool wees nie, behalwe gedurende 'n voorgeskrewe pouse, of gedurende die tydperk vandat hy die skoolterrein betree totdat met die skoolprogram 'n aanvang geneem word, of behalwe vir die doel om 'n kleedkamer te besoek of van klasse te verwissel.

(2) Geen ingeskreve leerling van enige skool in 'n gebied in Bylae A vermeld mag op enige skooldag waarop hy hom op die skoolterrein van die betrokke skool bevind, aan enige aktiwiteite deelneem wat nie onder die toesig van 'n personeellid van sodanige skool staan nie en wat nie direkte verband hou met sy skoolonderrig aan die skool nie.

(3) Behoudens die bepalings van paragraaf (1) mag geen leerling op enige skooldag gedurende die ure waartydens normaalweg onderrig verleen word aan 'n skool in 'n gebied in Bylae A vermeld, waar hy as leerling ingeskryf is, buite die grense van 'n perseel wat normaalweg gebruik word as woonplek vir mense, wees nie. Met dien verstande dat die bepalings van hierdie paragraaf nie van toepassing is nie ten opsigte van 'n leerling wat onderweg is na of van die skool waar hy as leerling ingeskryf is.

(4) Geen persoon wat nie 'n leerling is van, of wat nie in diens is by 'n skool in 'n gebied in Bylae A vermeld nie, mag te eniger tyd die perseel of geboue van daardie skool betree of daarop of daarin aanwesig wees nie.

(5) 'n Lid van 'n Mag kan te eniger tyd ten opsigte van 'n bepaalde persoon, skool of geval skriftelik vrystelling van enige van die bepalings van parrawe (1) tot en met (4) verleen.

Control of school boycotts

3. (1) No registered pupil in any school in an area mentioned in Schedule A shall on any school day whilst being on the school premises during the hours during which tuition is normally given, be outside a classroom of such school, unless it is during a prescribed break, or during the period from entering the school premises until the commencement of the school programme, or except for the purpose of visiting the dressing room or to change classes.

(2) No registered pupil of any school in an area mentioned in Schedule A shall on any school day, whilst being on the premises of such a school, partake in any activities which are not supervised or ordered by a member of the personnel of such a school, and which do not have direct bearing on his tuition at such a school.

(3) Subject to the provision of paragraph (1) no pupil shall on any school day during the hours during which tuition is normally given at the school where he is registered as a pupil, in an area mentioned in Schedule A be outside the boundaries of premises normally used for human habitation: Provided that the provisions of this paragraph are not applicable to a pupil *en route* to or from the school where he is registered as a pupil.

(4) No person who is not a pupil at, or is not employed at a school in an area mentioned in Schedule A, shall at any time enter upon or be on the premises or in the buildings of such a school.

(5) A member of a Force may at any time, with regard to a certain person, school or matter, grant written exemption from any of the provisions of paragraphs (1) up to and including (4).

SCHEDULE A**Orders****Control over non-residents of an area**

1. No person who is not resident in the areas as described in Schedule B or who cannot prove to the satisfaction of a member of a Force that he is so resident may enter or be in such area without the written permission of a member of a Force and subject to such condition as such a member may deem necessary or expedient, as specified in such written permission.

- (7) Sodanige begrafnisseremonie word nie met betrekking tot meer as een oorledene gehou nie en geen sodanige seremonie word bygewoon deur meer as 200 persone nie.
- (8) Geen sodanige begrafnisseremonie mag langer as vier uur duur nie.
- (9) Die gemelde Afdelingskommissaris van die Suid-Afrikaanse Polisie kan, op skriftelike aansoek en onderworpe aan die voorwaardes, as daar is, wat hy goedvind, vrystelling van enige of al die bogemelde beperkings verleen.

Verbod op byeenkomste

3. BYLAE B

Conditions in respect of certain funeral ceremonies in the areas mentioned in Schedule B

2. Any funeral ceremony, including any memorial service, commemorative service, funeral procession or burial in respect of any person who has apparently died as a result of unnatural causes, which is being held in an area mentioned in Schedule B, shall be held subject to the following restrictions:

- (1) No such funeral ceremonies may take place during weekends or on public holidays.
- (2) No memorial or commemorative service in connection with a funeral of a deceased person referred to above, shall be held out of doors.
- (3) Only an ordained minister of a religious denomination or organization may act as a speaker during any proceedings at any such funeral ceremony.
- (4) Persons attending such funeral shall only travel by vehicle from the place where the memorial or commemorative service has taken place to the place where the deceased is to be buried, and along a route determined by the mentioned Divisional Commissioner of the South African Police.
- (5) No flags, banners, placards, pamphlets, or posters shall be displayed or distributed at or during such funeral ceremony.
- (6) No public address system shall be used at or during such funeral ceremony.
- (7) A particular funeral ceremony shall not be held with regard to more than one such deceased person and no such ceremony shall be attended by more than 200 persons.
- (8) A particular funeral ceremony of such a deceased person shall not last for more than four hours.
- (9) The said Divisional Commissioner of the South African Police may, on written application and subject to such conditions, if any, as he may deem fit, grant exemption from any or all of the above-mentioned restrictions.

Prohibition on gatherings

3. (1) No organisation mentioned in Schedule D shall organize, arrange, hold or otherwise bring about any gathering in any building in a magisterial district mentioned in Schedule C and no person shall organize, arrange, hold or otherwise bring about such a gathering on behalf of or under the auspices of or with the assistance of such an organization.

(2) No person shall at any time attend such gathering or propagate, encourage or promote such gathering or the attendance thereof or do so or attempt to do so.

(3) No person shall print, publish or disseminate a notice in which such a gathering has been arranged or advertised.

(4) A Divisional Commissioner of the South African Police may, on written application and subject to such conditions, if any, as he may deem fit, grant exemption from the above-mentioned orders.

SCHEDULE B

Orders

Control of school boycotts

1. (1) No registered pupil in any school in an area mentioned in Schedule A, shall on any school day whilst being on the school premises during the hours during which tuition is normally given, be outside a classroom of such school, unless it is during a prescribed break, or during the period from entering the school premises until the commencement of the school programme, or except for the purpose of visiting a dressing room or to change classes.

(2) No registered pupil of any school in an area mentioned in Schedule A shall on any school day whilst being on the premises of such a school, partake in any activities which are not supervised or ordered by a member of the personnel of such a school, and which do not have direct bearing on his tuition at such a school.

(3) Subject to the provisions of paragraph (1) no pupil shall on any school day during the hours during which tuition is normally given at the school where he is registered as a pupil, in an area mentioned in Schedule A, be outside the boundaries of premises normally used for human habitation: Provided that the provisions of this paragraph are not applicable to a pupil *en route* to and from the school where he is registered as a pupil.

(4) No person who is not a pupil at, or is not employed at a school in an area mentioned in Schedule A, shall at any time enter upon or be on the premises or in the buildings of such a school.

(2) Geen persoon mag te eniger tyd enige sodanige byeenkoms bywoon, of die bywoning daarvan propageer, aanmoedig of bevorder, of poog om dit te doen nie.

(3) Niemand mag 'n kennisgewing waardeur so 'n byeenkoms belê word of geadverteer word, druk, publiseer of versprei nie.

(4) 'n Afdelingskommissaris van die Suid-Afrikaanse Polisie kan, op skriftelike aansoek, vrystelling van die bogenoemde bevele verleen.

Verbod op publikasies

3. (1) Geen organisasie in Bylae C vermeld, mag enige plakkaat, pamphlet, strooi- of aanplakbiljet of ander publikasie, maak, vervaardig, druk, reproduuseer, publiseer, uitdeel, versprei of vertoon nie.

(2) Geen persoon mag namens of onder die beskerming of met die medewerking of ten behoeve van so 'n organisasie enige plakkaat, pamphlet, strooi- of aanplakbiljet of ander publikasie maak, vervaardig, druk, reproduuseer, publiseer, uitdeel, versprei of vertoon nie.

(3) 'n Afdelingskommissaris van die Suid-Afrikaanse Polisie kan, op skriftelike aansoek, vrystelling van enige van al die bogemelde bevele verleen.

Verbod op publikasie van toesprake van ampsdraers en beampete van sekere organisasies

4. (1) Niemand mag, behalwe vir die doeleinnes van die verrigtinge van 'n gereghof, sonder die toestemming van die Afdelingskommissaris van die Suid-Afrikaanse Polisie enige toespraak, uitspraak, uitlating, geskrif of verklaring, of 'n uittreksel uit of opname of weergawe van 'n toespraak, uitspraak, uitlating, geskrif of verklaring, wat te eniger tyd op enige plek gemaak of voortgebring is deur enige ampsdraer of beampte van enige organisasie vermeld in Bylae C, druk, publiseer, versprei of deur meganiese of ander middels weergee nie.

(2) By die toepassing van paragraaf (1) beteken "ampsdraer" en "beampte", met betrekking tot 'n organisasie vermeld in Bylae C, onderskeidelik 'n ampsdraer en 'n beampte soos omskryf, met betrekking tot 'n organisasie, in artikel 1 van die Wet op Binnelandse Veiligheid, 1982 (Wet 74 van 1982).

Beperkings op sekere begrafnis

5. Enige begrafnisseremonie, met inbegrip van enige roudiens, gedenkdiens, begrafnisstoet of teraardebestelling ten opsigte van enige persoon wat oënskynlik aan onnatuurlike oorsake gesterf het, wat gehou word in 'n gebied in Bylae A vermeld, vind plaas onderhewig aan die volgende beperkings:

(1) Geen sodanige begrafnisseremonie mag gedurende naweke of openbare vakansiedae gehou word nie.

(5) No person shall teach, address or speak to any pupil or pupils in any school or on any school premises in the areas mentioned in Schedule A, in respect of any matter which does not form part of the official prescribed syllabus or which is not necessary for the purposes of tuition in accordance with such syllabus or the continuation of normal school activities.

(6) A member of a Force may at any time, with regard to a certain person, school or matter, grant written exemption from any of the abovenamed orders.

Prohibition on gatherings

2. (1) No organisation mentioned in Schedule C shall organise, arrange or hold or otherwise bring about any gathering in any building in a magisterial district mentioned in Schedule D, and no person shall organise, arrange, hold or otherwise bring about such a gathering on behalf of or under the auspices of or with the assistance of such an organisation.

(2) No person shall at any time attend such gathering or propagate, encourage or promote such gathering or the attendance thereof or do so or attempt to do so.

(3) No person shall print, publish or disseminate a notice in which such a gathering has been arranged or advertised.

(4) A Divisional Commissioner of the South African Police may, on written application, grant exemption from the above-mentioned orders.

Prohibition on publications

3. (1) No organisation mentioned in Schedule C, shall make, manufacture, print, reproduce, publish, distribute, disseminate or display any placard, pamphlet, hand-bill or poster or other publication.

(2) No person shall make, manufacture, print, reproduce, publish, distribute, disseminate or display any placard, pamphlet, hand-bill or poster or other publication in the name of or under the auspices of or with the assistance of or on behalf of such an organisation.

(3) A Divisional Commissioner of the South African Police may, on written application, grant exemption from any or all of the above-mentioned orders.

Prohibition on the publication of speeches of office-bearers and officers of certain organisations

4. (1) Nobody shall, except for the purposes of the proceedings of any court of law, without the permission of the Divisional Commissioner of the South African Police, print, publish, disseminate or reproduce by mechanical or other means any speech, pronouncement, utterance, writing or statement, or any extract from, or recording or reproduction of, a speech, pronouncement, utterance, writing or statement made or produced at any time at any place by any office-bearer, or officer of any organisation mentioned in Schedule C.

(2) For the purpose of paragraph (1) "office-bearer" and "officer", in relation to any organisation mentioned in Schedule C, means an office-bearer and an officer, respectively, as defined in section 1 of the Internal Security Act, 1982 (Act 74 of 1982), in relation to an organisation.

Restriction in respect of certain funerals

5. Any funeral ceremony, including any memorial service, commemorative service, funeral procession or burial, in respect of any person who has apparently died as a result of unnatural causes, which is being held in an area mentioned in Schedule A, shall be held subject to the following restrictions:

(1) No such funeral ceremony may take place during weekends or on public holidays.

- (5) Geen vlae, baniere, plakkate, pamphlette of aanplakbiljette mag by of tydens sodanige begrafnisseremonie vertoon of versprei word nie.
- (6) Geen luidsprekerstelsel mag by of tydens sodanige begrafnisseremonie gebruik word nie.
- (7) 'n Bepaalde begrafnisseremonie word nie met betrekking tot meer as een sodanige oorledene gehou nie en geen sodanige seremonie word bygewoon deur meer as 200 persone nie.
- (8) 'n Bepaalde begrafnisseremonie van so 'n oorledene mag nie langer as vier uur duur nie.
- (9) Die gemelde Afdelingskommissaris van die Suid-Afrikaanse Polisie kan, op skriftelike aansoek en onderworpe aan die voorwaardes, as daar is, wat hy goedvind, vrystelling van enige of al die bogemelde bevele verleen.

- (2) No such memorial or commemorative service in connection with a funeral of a deceased person referred to above, shall be held out of doors.
- (3) Only an ordained minister of a religious denomination or organisation may act as a speaker during any proceedings at any such funeral ceremony.
- (4) Persons concerned who are attending such funeral shall only travel by vehicle from the place where the memorial or commemorative service has taken place to the place where the deceased is to be buried, and along a route determined by the mentioned Divisional Commissioner of the South African Police.
- (5) No flags, banners, placards, pamphlets or posters shall be displayed or distributed at or during such funeral ceremony.
- (6) No public address system shall be used at or during such funeral ceremony.
- (7) A particular funeral ceremony shall not be held with regard to more than one such deceased person and no such ceremony shall be attended by more than 200 persons.
- (8) A particular funeral ceremony of such a deceased person shall not last for more than four hours.
- (9) The said Divisional Commissioner of the South African Police may, on written application and subject to such conditions, if any, as he may deem fit, grant exemption from any or all of the above-mentioned orders.
