No. 64 of 1986: Payment of Members of Parliament Amendment Act, 1986.

WET

Tot wysiging van die Wet op die Betaling van Parlementslede, 1974, ten einde voorsiening te maak vir verdere vrystellings van die verbeuring van bedrae geld deur lede weens hul versuim om sekere vergaderings by te woon; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 2 van Wet 40 van 1974, soos vervang deur artikel 1 van Wet 95 van 1985.

1. Artikel 2 van die Wet op die Betaling van Parlementslede, 1974, word hierby gewysig—
- (a) deur paragraaf (b) van subartikel (3) deur die volgende paragraaf te vervang:
 “(b) om 'n vergadering van die Huis waarvan hy 'n lid is of 'n vergadering van die Huise in gesamentlike sitting by te woon, ten opsigte van 'n verdere tydperk van afwesigheid wat—
- (i) **[van hoogstens]** 25 dae gedurende 'n sessie van die Parlement waarin die begroting van uitgawes vir die gewone administratiewe dienste van 'n boekjaar oorweeg word; en
- (ii) **[van hoogstens]** sewe dae gedurende enige ander sessie van die Parlement, nie te bowe gaan nie, behalwe op gesag van die Speaker ten opsigte van 'n bepaalde sessie van die Parlement verleen om redes wat hy voldoende ag; of”; en
- (b) deur paragraaf (c) van subartikel (3) deur die volgende paragraaf te vervang:
 “(c) om 'n vergadering van 'n komitee in daardie subartikel vermeld, by te woon **[ten opsigte van 'n verdere tydperk van afwesigheid van hoogstens een dag uit elke vier dae waarop die betrokke komitee byeenkom wanneer die Parlement geprorogeer is of wanneer al drie Huise langer as 30 dae gedurende 'n sessie van die Parlement verdaag is]**, indien sy afwesigheid nie aan 'n omstandigheid in paragraaf (a) van hierdie subartikel beoog, te wye is nie maar deur die Speaker verskoon word by aanvoering van goeie gronde, tot sy bevrediging, deur die lid.”.

ACT

To amend the Payment of Members of Parliament Act, 1974, so as to provide for further exemptions from the forfeiture of amounts of money by members on account of their failure to attend certain meetings; and to provide for matters connected therewith.

(English text signed by the State President.)
(Assented to 23 June 1986.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

1. Section 2 of the Payment of Members of Parliament Act, 1974, is hereby amended—
- 5 (a) by the substitution for paragraph (b) of subsection (3) of the following paragraph:
- “(b) to attend a meeting of the House of which he is a member or a meeting of the Houses in joint sitting, in respect of any further period of absence not exceeding—
- 10 (i) [not exceeding] 25 days during any session of Parliament in which the estimates of expenditure for the ordinary administrative services of any financial year are considered; and
- 15 (ii) [not exceeding] seven days during any other session of Parliament, except on the authority of the Speaker granted in respect of a particular session of Parliament for reasons that he considers adequate; or”; and
- 20 (b) by the substitution for paragraph (c) subsection (3) of the following paragraph:
- “(c) to attend a meeting of a committee referred to in that subsection [in respect of a further period of absence not exceeding one day out of every four days on which the committee in question meets when Parliament is prorogued or when all three Houses are adjourned for longer than 30 days during a session of Parliament], if his absence is not due to any circumstance contemplated in paragraph (a) of this subsection but is condoned by the Speaker on good cause shown to his satisfaction by the member.”.

Amendment of section 2 of Act 40 of 1974, as substituted by section 1 of Act 95 of 1985.

2. This Act shall be called the Payment of Members of Parliament Amendment Act, 1986. Short title.
