ORDER BY THE DIVISIONAL COMMISSIONER OF
THE SOUTH AFRICAN POLICE FOR THE WESTERN
TRANSVAAL DIVISION

Under the powers vested in me by virtue of regulation 7 (1) of the Regulations promulgated under the Public Safety Act, 1953 (Act 3 of 1953), by Proclamation R. 109 of 12 June 1986, I, Gerhardus de Waal, Divisional Commissioner of the South African Police for the Western Transvaal Division, hereby issue with reference to the areas set out in Schedule A in the Magisterial Districts of Potchefstroom, Oberholzer, Klerksdorp, Ventersdorp, Fochville, Christiana, Bloemhof, Delareyville, Lichtenburg, Schweizer-Reneke, Wolmaransstad, Swartruggens, Koster and Marico, the orders set out in Schedule B in respect of funeral ceremonies, including any memorial service, commemorative service, funeral procession or burial of any person who has apparently died as a result of unnatural causes.

Uit hoofde van die bevoegdheid my verleen ingevolge regulasie 7 (1) van die Regulasies uitgevaardig kragtens die Wet op Openbare Veiligheid, 1953 (Wet 3 van 1953), by Proklamasie R. 109 van 12 Junie 1986, herroep ek, Christoffel Anthonie Swart, Afdelingskommissaris van die Suid-Afrikaanse Polisie vir die Afdeling Westelike Provinsie, hierby die bevele uiteengesit in paragraaf 5 van Bylæ B by Goewermentskennisgewing 1355 van 21 Junie 1986 en vaardig ek met betrekking tot die gebiede vermeld in Bylæ A in die landdrosdistrik van Wynberg, die bevele uiteengesit in Bylæ B uit ten opsigte van begrafnisseremonies, met inbegrip van enige roudiens, gedenkdiens, begrafnisstoet of teraardebestelling ten opsigte van persone wat oënskynlik aan onnatuurlike oorsake gesterf het.

1. (1) Geen sodanige begrafnisseremonie word gehou, tensy 'n skriftelike kennisgewing van die voorneme om dit te hou, deur die persoon wat die seremonie reël of vir die hou daarvan verantwoordelik is, aan die stasiebevelvoerder in wie se polisiewyk sodanige seremonie gehou staan te word, oorhandig is nie.

(2) Sodanige skriftelike kennisgewing moet besonderhede wat die betrokke oorledene identifiseer, sowel as die datum, tyd en plek van die voorgenome begrafnisseremonie bevat en moet genoemde stasiebevelvoerder nie later as 12 ure voor die voorgenome begrafnisseremonie bereik nie.

ORDERS BY THE DIVISIONAL COMMISSIONER OF THE SOUTH AFRICAN POLICE FOR THE WESTERN PROVINCE DIVISION

By virtue of the powers vested in me in terms of regulation 7 (1) of the Regulations promulgated under the Public Safety Act, 1953 (Act 3 of 1953), by Proclamation R. 109 of 12 June 1986, I, Christoffel Anthonie Swart, Divisional Commissioner of the South African Police for the Western Province Division, hereby repeal the orders set out in paragraph 5 of Schedule B to Government Notice 1355 of 21 June 1986 and issue with reference to the areas set out in Schedule A in the Magisterial District of Wynberg, the orders set out in Schedule B in respect of funeral ceremonies, including any memorial service, commemorative service, funeral procession or burial, in respect of persons who have apparently died as a result of unnatural causes.

SCHEDULE A

1. In the Magisterial District of Wynberg, the areas known by the names indicated in column 1 hereunder and demarcated and described in the Government Notices, the numbers and dates of which appear in columns 2 and 3, respectively, hereunder, opposite the names of the areas in question:

SCHEDULE B

1. (1) No such funeral ceremony shall be held, unless a written notice of the intention to hold it has been handed, by the person who organizes the ceremony or who is responsible for the holding thereof, to the station commander in whose police area such ceremony is to be held.

(2) Such written notice shall contain particulars identifying the deceased concerned as well as the date, time and place of the intended funeral ceremony and shall reach the said station commander not later than 12 hours before the intended funeral ceremony.

(3) Geen sodanige begrafnisseremonie mag gedurende naweke of op openbare feesdae gehou word nie.

(4) Geen roudiens of gedenkdiens wat verband hou met 'n begrafnis van 'n oorledene soos hierbo bedoel, word in die ooplug gehou nie.

(5) Slegs 'n geordende leraar van 'n godsdienstige denominasie of organisasie mag as spreker tydens enige vertettinge by so 'n begrafnisseremonie optree: Met dien verstande dat so 'n leraar by so 'n seremonie op geen wyse enige staatsvorm of enige beginsel van beleid van 'n regering van 'n staat, of enige boikotaksie, die bestaan van 'n nootoestand, die optrede van 'n Mag of 'n lid van 'n Mag mag verdedig, aanval, kritiseer, propageer of bespreek nie.

(6) Die betrokke begrafnisgangers moet slegs per voertuig vanaf die plek waar die roudiens of gedenkdiens plaasgevind het na die plek waar die oorledene teraardebestel word, beweeg en slegs langs die kortste roete tussen gemelde plekke.

(7) Geen vlae, baniere, plakkate, pamphlette of aanplakbiljette mag by of tydens die begrafnisseremonie vertoon of versprei word nie.

(8) Geen luidsprekerstelsel mag by of tydens die begrafnisseremonie gebruik word nie.

(9) 'n Bepaalde begrafnisseremonie word nie met betrekking tot meer as een sodanige oorledene gehou nie en geen sodanige seremonie word bygewoon deur meer as 200 persone nie.

(10) 'n Bepaalde begrafnisseremonie mag nie langer as vier ure duur nie.

2. Die gemelde Afdelingskommissaris kan, op skriftelike aansoek en onderworpe aan die voorwaardes, as daar is, wat hy bepaal, vrystelling van enige van of al die bogemelde bevelle verleen.

(3) No such funeral ceremony may take place during weekends or on public holidays.

(4) No memorial or commemorative service connected with a funeral of a deceased person referred to above, shall be held out of doors.

(5) Only an ordained minister of a religious denomination or organisation may act as a speaker during any proceedings at any such funeral ceremony: Provided that such a minister shall not at such a ceremony in any manner defend, attack, criticise, propagate or discuss any form of government, any principal or policy of a government of a state, any boycott action, the existence of a state of emergency or any action by a Force or a member of a Force.

(6) Persons concerned who are attending the funeral shall only travel by vehicle from the place where the memorial or commemorative service has taken place to the place where the deceased is to be buried, and only along the shortest route between the said places.

(7) No flags, banners, placards, pamphlets or posters shall be displayed or distributed at or during the funeral ceremony.

(8) No public address system shall be used at or during the funeral ceremony.

(9) A particular funeral ceremony shall not be held with regard to more than one such deceased person and no such ceremony shall be attended by more than 200 persons.

(10) A particular funeral ceremony shall not last for more than four hours.

2. The said Divisional Commissioner may, on written application and subject to such conditions, if any, as he may determine grant exemption from any or all of the above-mentioned orders.
