JUDGES' REMUNERATION AMENDMENT ACT, 1986

Act No. 76, 1986

GENERAL EXPLANATORY NOTE:

ACT

To amend the Judges' Remuneration Act, 1978, so as to increase the salaries of judges of the Supreme Court of South Africa; and to provide for matters connected therewith.

(English text signed by the State President.)
(Assented to 27 June 1986.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

1. The following Schedule is hereby substituted for the Schedule to the Judges' Remuneration Act, 1978:

5 2. This Act shall be called the Judges' Remuneration Amendment Act, 1986, and shall be deemed to have come into operation on 1 April 1986.
