Uit hoofde van die bevoegdheid my verleen ingevolge regulasie 7 (1) van die Regulasies uitgevaardig kragtens die Wet op Openbare Veiligheid, 1953 (Wet 3 van 1953), by Proklamasie R. 109 van 12 Junie 1986, vaardig ek, Christiaan Hendrik Roberts, Afdelingskommissaris van die Suid-Afrikaanse Polisie vir die Afdeling Noord-Natal, hierby met betrekking tot die gebiede vermeld in Bylae A in die landdrosdistrikte van Laer Umfolozi, Mtunzini, Hlabisa, Dundee en Glencoe, die bevele uiteengesit in Bylae B uit.

BYLAE A

1. In die landdrosdistrik van Laer Umfolozi die gebied bekend as—
 - (a) Madlebe stamgebied (tradisioneel bekend as die Matshana gebied), soos afgebaken en omskryf in Goewermentskennisgewing 1186 van 31 Julie 1959.
2. In die landdrosdistrik van Mtunzini die gebied bekend as—
 - (a) Vulendlela woongebied (tradisioneel bekend as die Kwa-Dlangeswa gebied), soos afgebaken en omskryf in Goewermentskennisgewing 214 van 13 Februarie 1970.

 - (a) Mphukuniyoni stamgebied, soos afgebaken en omskryf in Goewermentskennisgewing 2288 van 17 Desember 1971.

ORDERS BY THE DIVISIONAL COMMISSIONER OF
THE SOUTH AFRICAN POLICE FOR THE NORTHERN
NATAL DIVISION

By virtue of the powers vested in me in terms of regulations 7 (1) of the Regulations promulgated under the Public Safety Act, 1953 (Act 3 of 1953) by Proclamation R. 109 of 12 June 1986, I, Christiaan Hendrik Roberts, Divisional Commissioner of the South African Police for the Northern Natal Division, hereby issue with reference to the areas as set out in Schedule A in the Magisterial Districts of Lower Umfolozi, Mtunzini, Hlabisa, Dundee and Glencoe, the orders set out in Schedule B.

SCHEDULE A

1. In the Magisterial District of Lower Umfolozi the area known as—
 - (a) Madlebe tribal area (traditionally known as Matshana area), as demarcated and described in Government Notice 1186 of 31 July 1959.
2. In the Magisterial District of Mtunzini the area known as—
 - (a) Vulendlela Township (traditionally known as Kwa-Dlangeswa area), as demarcated and described in Government Notice 214 of 13 February 1970.
3. In the Magisterial District of Hlabisa the area known as—
 - (a) Mphukuniyoni tribal area, as demarcated and described in Government Notice 2288 of 17 December 1971.
4. In the Magisterial District of Dundee the area known as—
 - (a) Sibongile Township, as demarcated and described in Government Notice 1182 of 15 August 1958.

5. In die landdrosdistrik van Glencoe die gebied bekend as—

- (a) Sithembele of Tembalihle woongebied, soos afgekken en omskryf in Goewermentskennisgewing 2161 van 17 Oktober 1947.

BYLAE B

Bevele

Beheer oor nie-inwoners van 'n gebied

1. Geen persoon wat nie in 'n gebied soos omskryf in Bylæ A woonagtig is nie of tot bevrediging van 'n lid van 'n Mag kan bewys dat hy aldus woonagtig is nie, mag so 'n gebied binnegaan of daarbinne bly nie sonder skriftelike toëstemming van 'n lid van 'n Mag en onderworpe aan die voorwaardes wat so 'n lid noodsaklik of dienstig ag en in sodanige skriftelike toëstemming bepaal.

Beheer oor skoolboikotte

2. (1) Geen ingeskreve leerling van enige skool in 'n gebied in Bylæ A vermeld, mag op enige skooldag waarop hy hom op die skoolterrein van daardie skool bevind gedurende die ure waartydens normaalweg aan daardie skool onderrig verleen word, buite 'n klaskamer van die skool wees nie, behalwe gedurende 'n voorgeskrewe pose, of gedurende die tydperk vandat hy die skoolterrein betree totdat met die skoolprogram 'n aanvang geneem word, of behalwe vir die doel om 'n kleedkamer te besoek of van klasse te verwissel.

(2) Geen ingeskreve leerling van enige skool in 'n gebied in Bylæ A vermeld mag op enige skooldag waarop hy hom op die skoolterrein van die betrokke skool bevind, aan enige aktiwiteite deelneem wat nie onder die toesig van 'n personeel lid van sodanige skool staan nie en wat nie direkte verband hou met sy skoolonderrig aan die skool nie.

(3) Behoudens die bepalings van paragraaf (1) mag geen leerling op enige skooldag gedurende die ure waartydens normaalweg onderrig verleen word aan 'n skool in 'n gebied in Bylæ A vermeld, waar hy as leerling ingeskryf is, buite die grense van 'n perseel wat normaalweg gebruik word as woonplek vir mense, wees nie: Met dien verstande dat die bepalings van hierdie paragraaf nie van toepassing is nie ten opsigte van 'n leerling wat onderweg is na of van die skool waar hy as leerling ingeskryf is.

(4) Geen persoon wat nie 'n leerling is van, of wat nie in diens is by 'n skool in 'n gebied in Bylæ A vermeld nie, mag te eniger tyd die perseel of geboue van daardie skool betree of daarop of daarin aanwesig wees nie.

(5) 'n Lid van 'n Mag kan te eniger tyd ten opsigte van 'n bepaalde persoon, skool of geval skriftelik vrystelling van enige van die bepalings van paragrafe (1) tot en met (4) verleen.

Verbod op besit van sekere artikels of voorwerpe

3. Geen persoon mag—

- (a) enige toestel waarmee 'n klip of enige ander projektiel gewerp kan word;
- (b) enige nagemaakte vuurwapen of enige ander voorwerp wat 'n afbeelding is van of lyk na 'n vuurwapen, handgranaat of ander ploftoestel; of
- (c) enige uniform, uniformstuk, T-hemp, vlag, banier of wimpel waarop die naam, wapen of embleem van enige organisasie genoem in Bylæ C uitgebeeld word,
in sy besit hê nie.

Brandstofbeheer

4. (1) Niemand mag in die gebiede soos omskryf in Bylæ A in besit wees van petrol in 'n houer van watter aard ook al nie, uitgesonner die brandstoffenk van 'n motorvoertuig; en

- (a) Sithembele or Tembalihle Township, as demarcated and described in Government Notice 2161 of 17 October 1947.

SCHEDULE B

Orders

Control over non-residents of an area

1. No person who is not resident in an area as described in Schedule A, or who cannot prove to the satisfaction of a member of a Force that he is so resident, may enter or be in such area without the written permission of a member of a Force and subject to such conditions as such a member may deem necessary or expedient and specify in such written permission.

Control of school boycotts

2. (1) No registered pupil in any school in an area mentioned in Schedule A shall on any school day whilst being on the school premises during the hours during which tuition is normally given, be outside a classroom of such school, unless it is during a prescribed break, or during the period from entering the school premises until the commencement of the school programme, or except for the purpose of visiting the dressing room or to change classes.

(2) No registered pupil of any school in an area mentioned in Schedule A shall on any school day, whilst being on the premises of such a school, partake in any activities which are not supervised or ordered by a member of the personnel of such a school, and which do not have direct bearing on his tuition at such a school.

(3) Subject to the provisions of paragraph (1) no pupil shall on any school day during the hours during which tuition is normally given at the school where he is registered as a pupil, in an area mentioned in Schedule A be outside the boundaries of premises normally used for human habitation: Provided that the provisions of this paragraph are not applicable to be pupil *en route* to or from the school where he is registered as a pupil.

(4) No person who is not a pupil at, or is not employed at a school in an area mentioned in Schedule A, shall at any time enter upon or be on the premises or in the buildings of such a school.

(5) A member of a Force may at any time, with regard to a certain person, school or matter, grant written exemption from any of the provisions of paragraphs (1) up to and including (4).

Prohibition on possession of certain articles or objects

3. No person shall be in possession of—

- (a) any device with which a stone or any other projectile can be cast;
- (b) any simulated fire-arm or any other object which is a copy of or which resembled any fire-arm, handgrenade or other explosive device; or
- (c) any uniform, part of a uniform, T-shirt, flag, banner or pennant on which the name, badge or emblem of any organisation mentioned in Schedule C is depicted.

Control over petrol

4. (1) No persons shall be in possession of petrol in a container of whatever nature, excluding the petrol tank of a motor vehicle; and

(2) niemand mag petrol uit die brandstoftank van 'n motorvoertuig in 'n houer van watter aard ook al uittap nie, behalwe met die skriftelike toestemming van 'n lid van 'n Mag.

BYLAE B

Bevele

Beheer oor skoolboikotte:

1. (1) Geen ingeskreve leerling van enige skool in 'n gebied in Bylae A vermeld, mag op enige skooldag waarop hy hom op die skoolterrein van daardie skool bevind gedurende die ure waartydens normaalweg aan daardie skool onderrig verleen word, buite 'n klaskamer van die skool wees nie, behalwe gedurende 'n voorgeskrewe pose, of gedurende die tydperk vandat hy die skoolterrein betree totdat met die skoolprogram 'n aanvang geneem word, of behalwe vir die doel om 'n kleedkamer te besoek of van klasse te verwissel.

(2) Geen ingeskreve leerling van enige skool in 'n gebied in Bylae A vermeld mag op enige skooldag waarop hy hom op die skoolterrein van die betrokke skool bevind, aan enige aktiwiteite deelneem wat nie onder die toesig van 'n personeel lid van sodanige skool staan nie en wat nie direkte verband hou met sy skoolonderrig aan die skool nie.

(3) Behoudens die bepalings van paragraaf (1) mag geen leerling op enige skooldag gedurende die ure waartydens normaalweg onderrig verleen word aan 'n skool in 'n gebied in Bylae A vermeld, waar hy as leerling ingeskryf is, buite die grense van 'n perseel wat normaalweg gebruik word as woonplek vir mense, wees nie. Met dien verstande dat die bepalings van hierdie paragraaf nie van toepassing is nie ten opsigte van 'n leerling wat onderweg is na of van die skool waar hy as leerling ingeskryf is.

(4) Geen persoon wat nie 'n leerling is van, of wat nie in diens is by 'n skool in 'n gebied in Bylae A vermeld nie, mag te eniger tyd die perseel of geboue van daardie skool betree of daarop of daarin aanwesig wees nie.

(5) 'n Lid van 'n Mag kan te eniger tyd ten opsigte van 'n bepaalde persoon, skool of geval skriftelik vrystelling van enige van die bovenoemde bevele verleen.

(a) Mzinoni Township, as demarcated and described in Proclamation 56 of 1908 and Government Notice 611 of 30 March 1979.

14. In the Magisterial District of Waterval-Boven the area known as—

(a) Emgwanya Township, as demarcated and described in Government Notice 1152 of 4 August 1967.

15. In the Magisterial District of Lydenburg the area known as—

(a) Mashising Township, as demarcated and described in Government Notice R. 926 of 15 June 1962.

SCHEDULE B

Orders

Control of school boycotts:

1. (1) No registered pupil in any school in an area mentioned in Schedule A shall on any school day whilst being on the school premises during the hours during which tuition is normally given, be outside a classroom of such school, unless it is during a prescribed break, or during the period from entering the school premises until the commencement of the school programme, or except for the purpose of visiting the dressing room or to change classes.

(2) No registered pupil of any school in an area mentioned in Schedule A shall on any school day, whilst being on the premises of such a school, partake in any activities which are not supervised or ordered by a member of the personnel of such a school, and which do not have direct bearing on his tuition at such a school.

(3) Subject to the provision of paragraph (1) no pupil shall on any school day during the hours during which tuition is normally given at the school where he is registered as a pupil, in an area mentioned in Schedule A be outside the boundaries of premises normally used for human habitation: Provided that the provisions of this paragraph are not applicable to a pupil en route to or from the school where he is registered as a pupil.

(4) No person who is not a pupil at, or is not employed at a school in an area mentioned in Schedule A, shall at any time enter upon or be on the premises or in the buildings of such a school.

(5) A member of a Force may at any time, with regard to a certain person, school or matter, grant written exemption from any of the abovenamed orders.
