

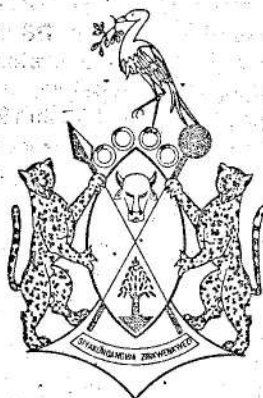

UNAUTHORIZED EXPENDITURE ACT, 1986

ACT

To apply a further sum of money towards the services of the Republic of Ciskei for the financial year ended on the thirty-first day of March 1985 for the purpose of meeting and covering certain unauthorized expenditure.

(English text signed by the President. Assented to on 8 July 1986).

BE IT ENACTED by the National Assembly as follows:-

1. **Revenue Fund charged with R6 168 281,10.** - The Revenue Fund is hereby charged with the sum of 6 168 281,10 to meet certain expenditure over and above the amounts with which the Revenue Fund of the Republic of Ciskei has been charged for the financial year which ended on the thirty-first of March 1985. Such expenditure is set forth in the Schedule to this Bill and is more particularly specified on page of the Report of the Auditor-General on the Accounts of the Republic of Ciskei and the Lower Authorities in the Area for the Financial Year 1984 — 1985.

2. **Short title.** - This Act shall be called the Unauthorized Expenditure Act, 1986.
