TUSSENVERKIESING.—RAAD VAN AFGEVAARDIGDES—KIESAFDELING BRICKFIELD

1. Kragtens die bevoegdheid my verleen by artikel 110 van die Kieswet, 1979 (Wet 45 van 1979), verklaar ek hiermee dat 'n vakature ontstaan het in die verteenwoordiging van die kiesafdeling Brickfield weens die bedanking van mnr. M. A. G. Joosub met ingang van 1 Julie 1986.

2. Kragtens die bevoegdheid my verleen by artikel 33 van die Kieswet, 1979 (Wet 45 van 1979)—

(a) bepaal ek hierby ingevolge die bepalings van artikels 34 en 110 van genoemde Wet—

(i) Maandag, 6 Oktober 1986, as die dag waarop 'n nominasiehof ten opsigte van die kiesafdeling Brickfield sitting sal hou om nominasies van verkiesingskandidate te ontvang vir die verkiezing van 'n lid van die Raad van Afgevaardigdes vir daardie kiesafdeling;

(ii) dat bedoelde nominasiehof om 10h00 sitting sal hou in Siviele Hof No. 6, Landdroskantoor, Sompseuweg, Durban;

(iii) dat ingeval 'n stemming nodig word in die bedoelde kiesafdeling omdat meer as een persoon behoorlik genomineer is by die sluiting van so 'n nominasiehof, die stemming op Woensdag, 12 November 1986, sal plaasvind; om 07h00 op bedoelde dag sal begin en om 21h00 daardie dag sal eindig; en

(b) stel ek hierby ingevolge genoemde bepalings, mnr. K. A. Templeton, Senior Landdrost, aan as kiesbeampte by die verkiezing in daardie kiesafdeling.

BY-ELECTION.—HOUSE OF DELEGATES—ELECTORAL DIVISION OF BRICKFIELD

1. Under the powers vested in me by section 110 of the Electoral Act, 1979 (Act 45 of 1979), I hereby declare that a vacancy has occurred in the representation of the Electoral Division of Brickfield on account of the resignation of Mr M. A. G. Joosub with effect from 1 July 1986.

2. Under the powers vested in me by section 33 of the Electoral Act, 1979 (Act 45 of 1979)—

(a) I hereby determine, in terms of the provisions of sections 34 and 110 of the said Act—

(i) that Monday, 6 October 1986 shall be the day on which a nomination court will sit in respect of the Electoral Division of Brickfield to receive nominations of candidates for election as a member of the House of Delegates for that electoral division;

(ii) that the said nomination court shall sit in Civil Court No. 6, Magistrate's Office, Sompseuw Road, Durban, at 10h00;

(iii) that if a poll becomes necessary in the said electoral division for the reason that more than one person shall have been duly nominated at the close of the sitting of the nomination court in question, the poll shall be taken on Wednesday, 12 November 1986; shall commence at 07h00 on the said day and shall close at 21h00 on that day; and

(b) I hereby appoint in terms of the said provisions Mr A. Templeton, Senior Magistrate, as the returning officer at the election in that electoral division.
